ADDENDUM TO COOPERATIVE AGREEMENT

THIS AGREEMENT, made by and between JACKSON COUNTY, MISSOURI, a Constitutional Home Rule Charter County of the State of Missouri, hereinafter referred to as "the County" and a Missouri not-for-profit corporation, COMMUNITY SERVICES LEAGUE 404 N. NOLAND ROAD INDEPENDENCE, MO 64050, hereinafter referred to as "Organization".


WHEREAS, pursuant to County Resolution 20739, dated September 9, 2021, the County and Organization entered into a Cooperative Agreement ("the Prior Agreement") to provide funding to be used for relocation assistance for residents of the Heart Village Mobile Home Park; and,

WHEREAS, the County deems it to be in the best interest of its citizenry to increase its financial support for this effort as authorized by Resolution 20889, dated February 28, 2022;

NOW THEREFORE, in consideration of the foregoing and the terms and provisions herein contained, the County and Organization respectively promise, covenant, and agree with each other as follows:

NOW, THEREFORE, it is agreed by and between the parties as follows:

- Except as specifically provided herein, the Prior Agreement shall remain in full force and effect pursuant to its terms.
- 2. Upon the execution of this Addendum, the County shall make a payment to the Organization in the amount of \$800,000.00. Organization shall disburse these



funds to tenants and former tenants of the Heart Village Mobile Home Park in a manner consistent with Exhibit A to the Prior Agreement.

- 3. This Addendum, together with the Prior Agreement, shall be effective as of September 1, 2021, and shall continue until August 31, 2022, unless sooner terminated pursuant to paragraph 6, 12, or 15 of the Prior Agreement. If the Prior Agreement is terminated by either party, the County shall pay only for those services actually performed by Organization as verified by the County's audit.
- 4. This Addendum, together with the Prior Agreement, incorporates the entire understanding and agreement of the parties.
