**AN ORDINANCE** appropriating \$11,302.00 from the undesignated fund balance of the 2022 Park Fund and authorizing the County Executive to execute an easement in favor of Beazer East, Inc., of Pittsburgh, PA, to allow for a permanent access easement across a portion of the Rock Island Rail Corridor.

WHEREAS, Beazer East, Inc., has requested an easement across a portion of the Rock Island Rail Corridor property located 6740 Stadium Drive, in Kansas City, to allow for the installation of permanent, non-exclusive access easement; and,

WHEREAS, the Director of Parks + Rec recommends the County Executive be authorized to execute the attached permanent easement in favor of Beazer East, Inc., to allow Beazer to access its adjacent property; and,

WHEREAS, the granting of the requested easement will not impact the rail corridor or park operations, as the area is currently undeveloped and not planned for future trail use; and,

WHEREAS, Beazer East, Inc., has agreed to pay the County easement and processing fees required by the County Code, totaling \$11,302.00, and,

WHEREAS, the execution of the attached easement is in the best interests of the health, welfare, and safety of the citizens of Jackson County; now therefore,

BE IT ORDAINED by the County Legislature of Jackson County, Missouri, that the following appropriation be and hereby is made:
