## SECOND ADDENDUM TO COOPERATIVE AGREEMENT

THIS Second Addendum to Agreement is made by and between JACKSON COUNTY, MISSOURI, a Constitutional Home Rule Charter County of the State of Missouri, hereinafter referred to as "the County" and a Missouri not-for-profit corporation, COMMUNITY SERVICES LEAGUE 404 N. NOLAND ROAD INDEPENDENCE, MO 64050, hereinafter referred to as "Organization".

WHEREAS, pursuant to County Resolution 20739, dated September 9, 2021, the County and Organization entered into a Cooperative Agreement ("the Prior Agreement") to provide funding to be used for relocation assistance for residents of the Heart Village Mobile Home Park; and,

WHEREAS, by Resolution 20889, dated February 28, 2022, the County entered into an Addendum with Organization to increase the amount available for relocation assistance; and,

WHEREAS, it is now appropriate that this assistance be further increased by the sum of \$253,570.00, to reimburse Organization for expenses incurred for demolition and water service incurred while the business of the mobile home park was wrapping up.

NOW THEREFORE, In consideration of the foregoing and the terms and provisions herein contained, the County and Organization respectively promise, covenant, and agree with each other as follows:

NOW, THEREFORE, it is agreed by and between the parties as follows:

- 1. Except as specifically provided herein, the Prior Agreement and Prior Addendum shall remain in full force and effect pursuant to their terms.
- 2. Upon the execution of this Addendum, the County shall make a payment to the Organization in the amount of \$253,570.00. Organization shall disburse these funds to pay for demolition costs and water service fees incurred on behalf of tenants and former tenants of the Heart Village Mobile Home Park.
- 3. This Second Addendum, together with the Prior Agreement and Prior Addendum, shall be effective as of September 1, 2021, and shall continue until December 31, 2022, unless sooner terminated pursuant to paragraph 6, 12, or 15 of the Prior Agreement.
- 4. This Second Addendum, together with the Prior Agreement and Prior Addendum, incorporates the entire understanding and agreement of the parties.
