# **Courthouse / City Hall**

### Jackson County Historic Truman Courthouse Renovation

Facility Demand, Operational Assessment, Space Planning, Interior Restoration and Renovation

In 2012, Piper-Wind Architects led a project team in the complete restoration of the 25,000 SF Historic Truman Courthouse on the town square in downtown Independence, MO. Several county departments were relocated back to the building, which also serves the public as home for the Jackson County Historical Society, a City of Independence Visitors Center and Tourism offices, museum spaces and an art gallery. PWA facilitated the space planning and programming for all tenants, meeting all current codes and accessibility standards, and maintaining architectural integrity of the time period and surrounding facility improvements. The final design also incorporated technological solutions to achieve goals and amenities. Exterior improvements included the restoration of the cupola, clock and bell tower. Interior improvements included the careful integration of an elevator to serve the three-story building, the restoration of historic spaces, finishes, ceiling heights, light fixtures and other improvements compatible with the original building's materials and finishes, without the addition of a single new doorway, and with only three small existing walls being partially removed. The roughly 5 million dollar construction project was completed in two phases in the fall of 2013. This project was the recipient of the American Public Works Association honor award for historic preservation in 2013 and a Missouri Preservation Honor Award in 2015.



### **Historic KCMO City Hall Interior Renovations**

#### City of Kansas City, Missouri

PWA was commissioned by the City of Kansas City, Missouri, originally in 1999, to develop design and construction drawings for various renovations to the historic Art Deco style 30-story tall City Hall. Since then, the contract has been extended many times to include the complete renovation of several whole floors, along with partial floors. The scope of work for each floor has involved gutting a substantial portion of the tenant spaces; renovation of mechanical systems; new lighting; installation of a new fire sprinkler system; new ceilings; new interior wall construction (for offices); restoration of hardware; refurbishment of existing stained wood doors and trim; and new interior finishes.

The design for the remodeling projects needed to set a standard for future City Hall, so we worked closely with the City to develop a design that created a work environment that would go beyond typical office interiors while at the same time be cost effective to construct. Meeting with staff from the various departments involved, we were able to develop space plan options to satisfy everyone's needs.

The renovations also had to integrate ADA compliant standards into the building, maintaining the historic Art Deco style, including compliant restrooms, stairways, and doors. PWA created a custom designed lever that could be added to the existing door knobs and would withstand the constant daily use and abuse required by it's internal fastening system. Milled out of the same bronze alloy as the original decorative Art Deco door hardware, these levers were added to the original door hardware, which were then refurbished, hand polished, and reinstalled to look like new.





Project Description -The United States Marine Corps (USMC) committed to taking the vacated 410,000 SF IRS facility located in Kansas City, MO for the use of various Marine Corps entities and reutilizing existing infrastructure to address sustainable design. The new MCEITS (Marine Corps Enterprise Information Technology Services) Data Center was its focal point – comprising 77,000 SF of renovated space. One of the appeals of the building was that the IRS had previously used the building for a similar computer operations center. Substantial modifications had to be made however, in the Electrical, Mechanical, and Fire Suppression Systems to meet Marine Corps requirements for their Data Center, as well as in IT, Tele-data, and Security Systems. The Marine Corps hoped to begin occupancy by mid-year 2008, although the Design Team did not get contracted until that time. The USMC anticipated occupancy of the remaining 330,000 SF at later dates.

Kansas City's downtown City Market is a complex of historic structures. **Bartle Hall Covention Center:** This project was constructed in two phases to allow for continued (and at times, very heavy) public use and was completed between January and October, 2016, given a fixed deadline between two major shows. The existing series of revolving doors were impossible for persons in wheelchairs to navigate and were replaced by a pair of one block long undulating glass wall entrance air lock vestibules that provided gathering space both within the vestibules and at curbside.

#### Municipal Auditorium Music Hall, Little Theater and Bartle Hall

**Conference Center:** Accessible routes and exits were compromised by non-compliant handrails, in addition to non-compliant restrooms, seating, signage, and serving counters. A major challenge was to determine ways to create ADA compliant solutions without denegrating the historic character of the building. One of the many solutions that PWA developed for the historic complex was a custom fabricated handrail bracket extension that allowed the existing historic bronze railings within the marble-lined lobbies to be raised to compliant ADA height without removing the existing brackets, patching their holes and providing new brackets at the proper height. Other solutions included providing new carpeting in the theater with contrasting colored risers and illuminated nosings for greater visiblity during the house darkened shows.

# Historic Swope Park Swimming Pool Renovation and Restoration

Exterior Restoration, Design, Engineering, CD's and CA for Parks Department

Built in 1941, Kansas City's historic Swope Park Swimming Pool has undergone several renovations, and we were tasked with restoring this Parks Dept. facility and exterior stone façade to its original condition, along with various other improvements to make the facility fully accessible.

Over its near 80-year history, various renovations were not necessarily in keeping with the original style, and the building has also seen a deterioration of its stonework, ceramic tiling, wood and metal trim, windows and electrical system. Care was taken to match the original stone using the correct mortar mix, cleaning methods and other important masonry preservation best practices. It is those details we most admire that are often the most vulnerable, succumbing not only to the effects of time and weather, but to the consequences of insensitive repairs, from inappropriate coatings to careless repointing. All defects have been restored or replaced, with the end result being a truly impressive example of historical preservation meeting 21st century needs. Additionally, original glazed tile in the locker and dressing rooms had decayed over the years, and care was taken to exactly match the original product and color.

Stone Restoration included extensive repointing, replacement, and complete restoration of all existing exterior stonework. Work also included thoroughly cleaning all exposed exterior masonry, and protection of all other historic elements of the building, pool deck, swimming and diving pools and landscaping. Existing gutters, downspouts, hardware and other elements were removed, restored, and reinstalled after at the completion of stonework. Careful consideration of flashing and drainage details was critical to ensuring restored elements would be maintained for decades to come. Modifications were also required at existing ramps and stairways to the pool deck, and at existing steel lintels and ornamental concrete moldings that had been damaged or had deteriorated over time. And all of this was achieved with careful consideration to satisfy current codes, all the while being sympathetic to the historical nature of the facility.



The Shelterwood Academy, in eastern Jackson County, Missouri, is a Christian Therapeutic Boarding School for at-risk teens. The word "Shelterwood" describes a forestry technique in which older, stronger trees shelter and protect younger trees on the forest floor until they stand, grow and thrive on their own. In the same way, Shelterwood offers struggling teens a safe, loving place to heal and flourish.

### **Starlight Theatre Improvements**

City of Kansas City, MO - Accessible Routes, Parking, Seating Bowl and Support Buildings

In 2012, the United States Department of Justice (DOJ) conducted a sample survey of dozens of Kansas City, Missouri city-owned facilities and cited the City for not abiding by the 1991 Americans with Disabilities Act (ADA) Civil Rights legislation for publicly owned buildings (Title II) in providing access to its buildings for persons with disabilities. One of the facilities that was partially audited by the DOJ was Starlight Theater, which was cited for numerous violations to the ADA Standards.

As required by the settlement agreement between the City and the DOJ, the City's design team did a complete assessment of the facility and discovered many other violations that needed to be remedied. Parking, signage, restrooms, concessions stands, and routes to and from the seating bowl have been found to not meet the ADA Standards. Many small and subtle improvements are being planned to make Starlight's amenities meet the ADA requirements. Assessment of the existing seating at Starlight Theatre has identified several non-compliant conditions, including number of wheelchair spaces, slope of accessible seating platforms, line-of-sight comparable to standing spectators and access to the seating sections from adjacent circulation routes. Proposed design modifications address these issues.

# Bartle Hall Convention Center / Municipal Auditorium Improvements

City of Kansas City, Missouri - Convention, Conf. Center, and Municipal Auditorium ADA and Other Upgrades

**Bartle Hall Covention Center Entrances:** This project was constructed in two phases to allow for continued, and at times, very heavy public use and was completed between January and October, 2016, given a fixed deadline between two major events. The existing series of revolving doors were impossible for persons in wheelchairs to navigate and were replaced by a pair of one block long, undulating glass wall entrance vestibules which created gathering spaces both within the vestibules and at curbside.

**Municipal Auditorium Music Hall, Little Theater and Bartle Hall Conference Center:** Accessible routes and exits were compromised by non-compliant handrails, in addition to non-compliant restrooms, seating, signage, and serving counters. A major challenge was to determine ways to create ADA compliant solutions without

denegrating the historic character of the building.

One of the many solutions that PWA developed for the historic complex was a custom fabricated handrail bracket extension that allowed the existing historic bronze railings within the marble walled lobbies to be raised to compliant ADA height without removing the existing brackets, patching their holes and providing new brackets at the proper height. Other solutions included providing new carpeting in the theater with contrasting colored risers and illuminated nosings for greater visiblity during the house darkened shows.



# Historic Swope Park Swimming Pool Renovation and Restoration

City of Kansas City, Missouri - Exterior Restoration, Design, Engineering, CD's and CA for Parks Department

Built in 1941, Kansas City's historic Swope Park Swimming Pool has undergone several renovations, and we were tasked with restoring this Parks Dept. facility and exterior stone façade to its original condition, along with various other improvements to make the facility fully accessible.

Over its near 80-year history, various renovations were not necessarily in keeping with the original style, and the building has also seen a deterioration of its stonework, ceramic tiling, wood and metal trim, windows and electrical system. Care was taken to match the original stone using the correct mortar mix, cleaning methods and other important masonry preservation best practices. It is those details we most admire that are often the most vulnerable, succumbing not only to the effects of time and weather, but to the consequences of insensitive repairs, from inappropriate coatings to careless repointing. All defects have been restored or replaced, with the end result being a truly impressive example of historical preservation meeting 21st century needs. Additionally, original glazed tile in the locker and dressing rooms had decayed over the years, and care was taken to exactly match the original product and color.

Stone Restoration included extensive repointing, replacement, and complete restoration of all existing exterior stonework. Work also included thoroughly cleaning all exposed exterior masonry, and protection of all other historic elements of the building, pool deck, swimming and diving pools and landscaping. Existing gutters, downspouts, hardware and other elements were removed, restored, and reinstalled after completion of stonework. Careful consideration of flashing and drainage details was critical to ensuring restored elements would be maintained for decades to come. Modifications were also required at existing ramps and stairways to the pool deck, and at existing steel lintels and ornamental concrete moldings that had been damaged or had deteriorated over time. And all of this was achieved with careful consideration to satisfy current codes, all the while being sympathetic to the historical nature of the facility. Location Kansas City, Missouri


