Dan Tarwater III, Chairman, called the meeting of the Jackson County Legislature to order.

1 ROLL CALL

3 APPROVAL OF THE JOURNAL OF THE PREVIOUS MEETING

A motion was made by Theresa Cass Galvin, seconded by Ronald E. Finley to approve the journal of the previous meeting held on October 04, 2021. The motion passed by a voice vote.

4 HEARINGS

Tony Miller and Ronald E. Finley, County Legislators, presented Resolution #20778, congratulating the University of Missouri - Kansas City School of Law on the 125th Anniversary of its founding, to the Law School Dean, Barbara Glesner Fines.

Brian Gaddie, Director of Public Works, introduced Dan Musser and Rick Davidson (online), from JCDC Partners, LLC, for an update on the new detention center project. Mr. Musser said many of the documents and timelines listed depend on the delivery method under consideration with the County's ordinance. The property acquisition closed on August 13, 2021, and tenant relocation is ongoing by County staff. The criteria document is complete and ready for County review. This document is about 1,500 pages long and defines the performance requirements for the project. This is necessary for the request for proposals (RFP) and request for qualifications (RFQ). The revised project budget has been updated and will be presented to the Public Works Committee at its next meeting. The delivery method requires the adoption of the ordinance that is to be introduced today. The RFQ is the first step in selecting a design build contractor. The County needs to finalize a selection committee and the selection criteria. The RFP has been submitted to the County for review. The design build contract will be released with the RFP and its final form depends on the approval of the ordinance. The topography and boundary surveys are complete. The environmental status will be completed soon. The City of Kansas City is supportive of the project. Community outreach meetings continue with the Blue Hills Neighborhood, the neighborhood where the project is located. The special use permit will be completed by the design build contractor. The flood plain permit will be completed once all residents are moved. The site will need to be raised above the 500 year flood plain. Many of these elements are dependent on the approval of Ordinance #5556, which impacts the budget and RFQ. JCDC Partners intends to address the Public Works Committee next week.

Theresa Cass Galvin, County Legislator, said seven weeks ago the discussion was that the RFQ would be complete in 30 days. She asked if the RFQ will be released by the first of November. Mr. Musser said the 30 day timeline was dependent on the approval of the delivery method. He said the proposal was submitted to the Purchasing Department and Compliance Department. Crissy Wooderson, Legislative Auditor, said neither Purchasing nor Compliance have seen that document. Brian Gaddie said the document is in his office and is being reviewed by the Public Works purchasing personnel. As soon as they are complete it will be forwarded to the other departments. Compliance has been involved in the process, but have not seen the completed documents. Ms. Galvin asked that this be prioritized and moved along.

Jalen Anderson, County Legislator, asked about the 1,500 page criteria document. Mr. Musser said this document includes information about the site, the building and security requirements that will be included in the selection process. This information will help the designer to create the project. Mr. Anderson asked if the standards for minority and labor union participation are included. Mr. Musser said those requirements will be part of the contract and part of the RFQ and RFP with workforce goals requested. Mr. Gaddie said the percentages used are those given by the

Compliance Office, 9.5% minority participation, 11.7% women's participation, and 9.5% veterans participation. Mr. Anderson asked about how much of this project is supported by labor unions. Frank White, County Executive, said he was shooting for the same goals as the airport - 35% minority participation. Mr. Anderson asked for labor union participation goals. Mr. Musser said the required goals are minimums and they intend to ask for higher goals.

Ronald E. Finley asked for a definition of "topo" as listed in the project update. Mr. Musser said that is topography – the grade of the site and ground elevation. Mr. Finley asked why the group cannot do what the County Executive requests and increase the WBE and MBE goals to 35%. He said the disparity study was conducted years ago based on the capacity within the County. This is a big project. Brian Gaddie said this matter is constricted by County ordinances. This is a byproduct of what the ordinance states. Crissy Wooderson said the County does not have an ordinance giving it authority to set a workforce participation. This approach was discussed with the legal department. Mr. Finley asked for follow up from the Compliance Office regarding this approach. Mr. Finley asked for more detailed information on the schedule. He has contractors contacting him about a timeline. Mr. Musser said, assuming the Legislature approves the delivery method by October 25, 2021, the RFQ will be released no later than November 1, 2021. They estimate a two week response period and one week to evaluate the responses. Those proposals would be due on December 6, 2021. They would evaluate those proposals with a notice to award released in early January. They plan to have a preproposal conference at the stadium after the RFQ is released. They have over 1,000 contacts they will be notifying about the project. Mr. Finley said he believes this is vague information and he would like a schedule as to when the bidding, the RFP, and the RFQ will be released. He said he wants a schedule as to when the building is going to get started. Mr. Gaddie said they have a very specific schedule, and the approval of the ordinance is the catalyst to everything else that needs to happen. The team is reluctant to release the timing and then have something come up that alters the schedule. Mr. Finley said these firms are anxious to reach out to those making this decision. Everyone wants a facility that will serve the public. Mr. Finley asked for a schedule of what's going to happen, how it is going to happen, and when it is going to happen. Rick Davidson said this schedule is conditional on getting the ordinance adopted to keep with the timelines. Dan Tarwater III said he advocates for an open process when the bidders can come and present information to the Legislature.

Jeanie Lauer, County Legislator, asked about the difference in the terms

design build and design to budget. Brian Gaddie said the confusion may be in the difference between make and model. Design build is a delivery methodology. The design to budget is the make within the model. It is subset of design build. The design to budget would be a contractor under the design build delivery method. All the pieces are tied together. The goal is to get the most design for the budget given. Mr. Finley said the question is which comes first. Mr. Gaddie said there is no first. The design build is a project procurement methodology. The design build contractor will sub out the specifics of the project. The budget and the 1,500 page criteria document will guide the project.

Crystal Williams, County Legislator, asked if there is a commitment to having the bidders come before the Legislature with presentations. Mr. Gaddie said that is something that must be discussed and evaluated. Ms. Williams said she is not comfortable discussing this bidding process with any of the people that are part of the bidding process. She wants a transparent and clean process.

Tony Miller said it is not every day that the County has a project of this magnitude. Everyone wants to do the right thing by our residents. Legislators should reflect on best practices and follow that guidance. Mr. Musser said the RFQ and RFP will outline how the process will work. They do not have any discussions with bidders once those documents have been published.
