WHEREAS, Kansas City has made the short list of cities in competition to host the 2026 FIFA World Cup soccer tournament; and,

WHEREAS, the local 2026 FIFA World Cup Host Committee is working to secure for Kansas City a role as a host city through strategical and tactical efforts outlined in the attached Cooperative Agreement among the Kansas City Sports Commission, the City of Kansas City, the Unified

Government of WyCo/KCK, Visit KC, and Sporting KC, and Addendum A thereto; and,

WHEREAS, by Resolution 20771, dated September 27, 2021, the Legislature previously authorized a contract for these services for the period of August 1 through December 31, 2021; and,

WHEREAS, the execution of the attached Cooperative Agreement and its attached Addendum A to provide for the continuation of these services, at a cost to the County in the amount of \$15,000.00 for the period January 1 through June 30, 2022, is in the best interests of the health, welfare, and safety of the citizens of Jackson County; now therefore,

BE IT RESOLVED by the County Legislature of Jackson County, Missouri, that the following transfer be and hereby is made:
