## IN THE COUNTY LEGISLATURE OF JACKSON COUNTY, MISSOURI

**A RESOLUTION** authorizing the Director of Finance and Purchasing to execute a renewal of the term and supply contract with Blue Cross and Blue Shield of Kansas City, MO, for the furnishing of employee group health insurance as an employee benefit for use countywide, under the terms and conditions of Request For Proposals No. 48-16.

**RESOLUTION NO. 19615**, October 16, 2017

**INTRODUCED BY** Dennis Waits and Greg Grounds, County Legislators

WHEREAS, by Resolution 19253, dated September 12, 2016, the Legislature did award a twelvemonth term and supply contract with two twelve-month options to renew for the furnishing of employee group health insurance as an employee benefit for use countywide to Blue Cross and Blue File #: 19615, Version: 1

Shield of Kansas City, MO, under the terms and conditions of Request For Proposals No. 48-16, as the lowest and best bid; and,

WHEREAS, the Director of Finance and Purchasing recommends that the County exercise its option to renew the agreement with Blue Cross and Blue Shield; and,

WHEREAS, certain changes within the healthcare system necessitate that the County offer its associates additional cost-efficient health insurance options provided through Blue Cross and Blue Shield; and,

WHEREAS, these options will result in the offering of three distinct healthcare plans with the addition of the Blue Select Network option within each plan that will provide variety and value for the County's associates; and,

WHEREAS, the plans offered will include the Blue Care HMO, Preferred Care PPO, Blue Saver PPO (QHDHP) with a Health Savings Account (HSA), Blue Care Exclusive Provider Organization (EPO), Preferred Care PPO - Blue Select Plus, and Blue Saver PPO (QHDHP) with a Health Savings Account (HSA); and,

WHEREAS, it is recommended that the County continue to partially fund the HSAs in the amount of \$1,000/\$1,500/\$2,000 for each tier, single, employee plus one, and family; and,

WHEREAS, this award is made on an as needed basis and does not obligate Jackson County to pay any specific amount, with the availability of funds subject to annual appropriation; and,

WHEREAS, the recommended plan total premium monthly rates are as follows:
