**INTRODUCED BY** Tony Miller, County Legislator

WHEREAS, the Department of Finance and Purchasing has solicited formal written bids on Invitation

to Bid No. 50-18 for the furnishing of park site furniture for use by the Parks + Rec Department at its

campgrounds and parks; and,

WHEREAS, a total of fifty-four notifications were distributed and seven responses were received and evaluated; and,

WHEREAS, following evaluation of the responsive bids received, the Department of Finance and Purchasing has recommended that the contract be split and awarded to the bidders submitting the lowest and best bid for each type of item; and,

WHEREAS, award as recommended would result in awards to the following bidders:

## <u>BIDDER</u>

Fry & Associates, Inc., North Kansas City, MO

R.J. Thomas Manufacturing Co., Cherokee, IA

and,

WHEREAS, pursuant to section 1054.6 of the Jackson County Code, the Director of Finance and Purchasing recommends the spilt award of a twenty-four month term and supply contract with three twelve-month options to extend for the furnishing of park site furniture for use by the Parks + Rec Department to Fry & Associates of North Kansas City, MO, and R.J. Thomas Manufacturing Co. of Cherokee, IA, under the terms and conditions of Invitation to Bid No. 50-18, as the lowest and best bidders meeting specifications for each item; and, WHEREAS, this award is made on an as needed basis and does not obligate Jackson County to pay any specific amount, with availability of funds for specific purchases subject to annual appropriation; now therefore,

BE IT RESOLVED by the County Legislature of Jackson County, Missouri, that award be made as recommended by the Department of Finance and Purchasing, and that the Department of Finance and Purchasing be and hereby is authorized to execute for the County any documents necessary for the accomplishment of the award and any necessary extensions; and,

BE IT FURTHER RESOLVED that the Department of Finance and Purchasing is authorized to make all payments, including final payment on the contracts, to the extent that sufficient appropriations to the using spending agency are contained in the then current Jackson County budget.
