## **RESOLUTION NO. 20188,** July 1, 2019

**INTRODUCED BY** Jeanie Lauer, County Legislator

WHEREAS, the Sheriff's Office has a need for the acquisition, installation, and repair of emergency

equipment for use in its fleet vehicles; and,

WHEREAS, the Sheriff's Office desires to continue to use Whelan equipment to ensure ease of

maintenance, and to avoid the need to stock replacement parts from multiple manufacturers; and,

WHEREAS, 911 Custom of Overland Park, KS, is the only authorized dealer for Whelan equipment in the greater Kansas City metropolitan area; and,

WHEREAS, pursuant to section 1030.1 of the <u>Jackson County Code</u>, the Sheriff's Office and the Director of Finance and Purchasing recommend the award of a twelve-month term and supply contract with two twelve-month options to extend for the furnishing, installation, and repair of emergency equipment for the Sheriff's office to 911 Custom of Overland Park, KS, as a sole source purchase; now therefore,

BE IT RESOLVED by the County Legislature of Jackson County, Missouri, that award be made as recommended by the Director and that the Director be, and is hereby, authorized to execute for the County any documents necessary to the accomplishment of the award; and,

BE IT FURTHER RESOLVED that the Department of Finance and Purchasing is authorized to make all payments, including final payment on the contract, to the extent that sufficient appropriations to the using spending agency are contained in the then current Jackson County budget.
