WHEREAS, required weekly testing of 349 unvaccinated County associates began the week of

October 4, 2021, and for an estimated 315 associates of the 16<sup>th</sup> Circuit Court began on October 25, 2021; and,

WHEREAS, funds from this appropriation will provide for COVID-19 test kits and laboratory services to be utilized by the County through University Health/TMC, under its contract with Sinochips Diagnostics, at \$50.00 per test for up to 664 County and 16th Circuit Court associates though the end of 2021; and,

WHEREAS, an appropriation is necessary to place the funds in the proper spending account; now therefore,

BE IT ORDAINED by the County Legislature of Jackson County, Missouri, that the following appropriation be and hereby is made:
