ORDINANCE NO. 5586, December 13, 2021

INTRODUCED BY Theresa Cass Galvin, County Legislator

WHEREAS, by Ordinance 5299, dated December 2, 2019, the Legislature did authorize the

acceptance of a grant in the amount of \$584,300.00 awarded by the Missouri Department of Social

Services for the Victims of Crime Act (VOCA) grant, for the period November 1, 2019, through

September 30, 2021; and,

WHEREAS, the Missouri Department of Public Safety has now awarded additional funds in the

amount of \$69,345.00, and authorized a three-month extension to the VOCA grant, through December 31, 2021; and,

WHEREAS, this additional allocation requires matching funds in the amount of \$13,258.07 to cover the unfunded portions of the program; and,

WHEREAS, an appropriation and transfer are necessary in order to place the grant and matching funds in the proper spending accounts; now therefore,

BE IT ORDAINED by the County Legislature of Jackson County, Missouri, that the following transfer and appropriation be and hereby are made:
