WHEREAS, the Parks + Rec Department, Public Works Department, Department of Corrections,

Sheriff's Office, Facilities Management Division, Assessment Department, and Medical Examiner's

Office all have a continuing need for automotive parts; and,

WHEREAS, pursuant to section 1030.4 of the Jackson County Code, the Director of Finance and Purchasing recommends the award of a thirty-two month term and supply contract with two twelvemonth options to extend, for the furnishing of automotive parts to AutoZone, of Memphis, TN, under the terms and conditions of the OMNIA Partners Contract No. R211201, an existing competitively-bid government contract; and,

WHEREAS, a thirty-two month contract is recommended so that the County's contract will be coterminous with the OMNIA Partners contract; and,

WHEREAS, this award is made on an as needed basis and does not obligate Jackson County to pay any specific amount, with the availably of funds for specific purchases subject to annual appropriation; now therefore,

BE IT RESOLVED by the County Legislature of Jackson County, Missouri, that award be made as recommended by the Director of Finance and Purchasing, and that the Director be and hereby is authorized to execute for the County any documents necessary for the accomplishment of the award; and,

BE IT FURTHER RESOLVED that the Director be and hereby is authorized to make all payments on the contract, and any extensions thereto, to the extent that sufficient appropriations are contained in the then current County budget
