WHEREAS, by Resolution 18602, dated September 15, 2014, the Legislature did authorize an Agreement with the Missouri Department of Social Services for the furnishing of child autopsies and associated services on an as-needed basis by the Jackson County Medical Examiner's Office, for compensation payable to Jackson County; and,

WHEREAS, this Agreement has been renewed annually since that time; and,
WHEREAS, the Department of Social Services desires to extend this Agreement for an additional
twelve-month period; and,
WHEREAS, the attached Renewal and Language Revision Agreement with the State adequately sets
out the rights and obligations of each party related to these as-needed medical examiner services
now therefore,
BE IT RESOLVED by the County Legislature of Jackson County, Missouri, that the County Executive
be and hereby is authorized to execute on behalf of the County the Renewal to the Agreement with
the Missouri Department of Social Services for as-needed autopsy services, for compensation
payable to the County.
