WHEREAS, subsequent addenda have brought the total authorization under this contract up to the

amount of \$369,050.00; and,

WHEREAS, the County Counselor recommends that he be authorized to execute a Fifth Addendum

to the Legal Services Agreement to provide for additional compensation to be payable to the firm in

the additional amount of \$356,500.00; now therefore,

BE IT RESOLVED by the County Legislature of Jackson County, Missouri, that the County Counselor

be and hereby is authorized to execute a Fifth Addendum to the Legal Services Agreement with

Seyferth, Blumenthal & Harris, LLP, of Kansas City, MO, for services to be performed through

December 31, 2022, at an actual cost to the County not to exceed \$356,500.00 in a form to be

approved by the County Counselor; and,

BE IT FURTHER RESOLVED that the Director of the Department of Finance and Purchasing be and

hereby is authorized to make all payments, including final payment, on the Addendum.
