WHEREAS, the Director of Finance and Purchasing has solicited formal written bids on Bid No. 45-22 for the furnishing of pump maintenance and repair services for use by the Parks + Rec Department at its marinas and campgrounds throughout the County; and, File #: 21010, Version: 0

WHEREAS, a total of 129 notifications were distributed and three responses were received and

evaluated; and,

WHEREAS, pursuant to section 1054.6 of the Jackson County Code, the Directors of Finance and

Purchasing and Parks + Rec recommend the award of twelve-month term and supply contracts with

one twelve-month option to extend to Letts, VanKirk and Associates of Kansas City, KS, and Alliance

Pump & Mechanical of Independence, MO, as the lowest and best bidders; and,

WHEREAS, a split award is recommended to allow for a rapid response to repairs needing

immediate attention; and,

WHEREAS, this award is made on an as needed basis and does not obligate the County to pay any

specific amount, with the availability of funds for specific purchases being subject to annual

appropriation; now therefore,

BE IT RESOLVED by the County Legislature of Jackson County, Missouri, that award be made as

recommended by the Directors of Finance and Purchasing and Parks + Rec, and that the Director of

Finance and Purchasing be, and hereby is, authorized to execute for the County any documents

necessary for the accomplishment of the award; and,

BE IT FURTHER RESOLVED that the Director of Finance and Purchasing is authorized to make all

payments, including final payment on the contract, to the extent that sufficient appropriations to the
