WHEREAS, pursuant to section 1054.6 of the Jackson County Code, the Directors of Finance and

Purchasing and Parks + Rec recommend the award of the contract for the infield turf to Mid-America

Golf & Landscape, Inc., of Lee's Summit, MO, for the reason that it has submitted the lowest and best

bid, at an actual cost to the County not to exceed \$1,447,535.00; now therefore,

BE IT RESOLVED by the County Legislature of Jackson County, Missouri, that award be made as

recommended by the Directors of Finance and Purchasing and Parks + Rec, and that the Director of

Finance and Purchasing be, and is hereby, authorized to execute for the County any documents

necessary to the accomplishment of the award; and,

BE IT FURTHER RESOLVED that the Director of Finance and Purchasing is authorized to make all

payments, including final payment on the contract.
