WHEREAS, the Sheriff's Office has a continuing need for electronic reporting and criminal investigation system subscription service and software support; and,

WHEREAS, pursuant to section 1030.1 of the Jackson County Code, the Sheriff and the Director of

support for criminal investigations for use by the Sheriff's Office from LeadsOnline, LLC, of Plano, TX,

an existing County vendor, at a cost to the County in the amount of \$7,551.00 in 2022, of which

amount \$5,673.00 has already been paid, and a total thirty-six month cost in the amount of

\$34,006.00, as a sole source purchase; and,

WHEREAS, award as a sole source is appropriate as LeadsOnline is the developer and owner of the

needed proprietary software and is capable of providing its maintenance; now therefore,

recommended by the Sheriff and the Director of Finance and Purchasing, and that the Director be,
