WHEREAS, the County Administration requested the Director of Finance and Purchasing to solicit proposals on Request for Proposals (RFP) No. 81-22 for health center construction, renovation, and capital improvements; and,

WHEREAS, a total of three notifications were distributed and viewed and three proposals were received and reviewed from the following:

Samuel U. Rodgers Health Center, Inc. Kansas City (Jackson County), MO Swope Health Services Kansas City (Jackson County), MO VNA Home and Health Hospice Kansas City (Jackson County), MO

and,

WHEREAS, pursuant to section 1054.6 of the Jackson County Code, the County Administration recommends the award of contracts for health center construction, renovation, and capital improvements to Samuel U. Rodgers Health Center, Inc., of Kansas City, MO, in the amount of \$1,100,000.00 and Swope Health Services of Kansas City, MO, in the amount of \$1,900,000.00 for the reason they have submitted the best proposals, at an aggregate cost to the County not to exceed \$3,000,000.00; and,

WHEREAS, a transfer is necessary to place the funds needed for these improvements in the proper spending account; now therefore,
