and all documents necessary to effect this settlement; and,

BE IT FURTHER RESOLVED that the Director of Finance and Purchasing be and hereby is

authorized to issue a check or checks in an amount totaling \$150,000.00 in full and complete

settlement of this claim, payable to Tiffany Cox and/or her attorney's office, The Meyers Law Firm LC,

pursuant to the specific direction of the County Counselor.
