WHEREAS, hardware upgrade and annual software maintenance agreements are considered sole

source purchases, as they can only be provided by the hardware and software's developer; and,

WHEREAS, pursuant to section 1030.1 of the <u>Jackson County Code</u>, 1984, the Director of Finance

and Purchasing and Clerk recommend the award of a contract for a hardware upgrade and software

maintenance and support for use by the Office of the Clerk of the County Legislature to Granicus of

St. Paul, MN, at an actual cost to the County in the amount of \$6,844.00, as a sole source purchase;
