## IN THE COUNTY LEGISLATURE OF JACKSON COUNTY, MISSOURI

**A RESOLUTION** authorizing the County Counselor to settle the claims of Ryan Dumas in the case styled Ryan Dumas v. Jackson County, Missouri, et al., No. 17-CV-00510, now pending in the U.S. District Court for the Western District of Missouri, for a total payment by the County of \$147,500.00.

WHEREAS, Ryan Dumas filed a lawsuit styled Ryan Dumas v. Jackson County, Missouri, et al., No. 17-CV-00510, now pending in the U.S. District Court for the Western District of Missouri, seeking compensation for alleged violations of her constitutional rights while incarcerated in the Jackson County Detention Center; and,

WHEREAS, after a thorough investigation and negotiations, the County Counselor recommends a settlement in the amount of \$147,500.00 to be paid by the County to Ryan Dumas and/or his attorneys, Hollingshead & Dudley; and,

WHEREAS, the proposed settlement will limit the County's financial obligation in this matter and is in the best interests of the health, safety, and welfare of the citizens of Jackson County; now therefore,

BE IT RESOLVED by the County Legislature of Jackson County, Missouri, that the County Counselor be and hereby is authorized to settle the claims of the Ryan Dumas\_by the total payment of

\$147,500.00, in full, final, and complete release of all of the claims against the County and all of its
employees, officers, agents, and servants, as to any damages incurred; and,
BE IT FURTHER RESOLVED that the County Counselor be and hereby is authorized to execute any
and all documents necessary to effect this settlement; and,
BE IT FURTHER RESOLVED that the Director of Finance and Purchasing be and hereby is
authorized to issue a check or checks in an amount totaling \$147,500.00 in full and complete
settlement of this claim, payable to Ryan Dumas and/or his attorneys, Hollingshead & Dudley,
pursuant to the specific direction of the County Counselor.
Effective Date: This Resolution shall be effective immediately upon its passage by a majority of the Legislature.
