## IN THE COUNTY LEGISLATURE OF JACKSON COUNTY, MISSOURI

**A RESOLUTION** transferring \$52,775.00 within the 2022 Anti-Crime Sales Tax Fund and authorizing the Prosecuting Attorney to execute a Cooperative Agreement with Ivanhoe Neighborhood Council of Kansas City, MO, for the furnishing of anti-violent crime and anti-drug prevention activities and services, at an additional cost to the County not to exceed \$52,775.00.

WHEREAS, the County has had a working relationship with Ivanhoe Neighborhood Council of Kansas City (Jackson County), MO, since 2014; and,

WHEREAS, Ivanhoe Neighborhood Council desires to establish a Striving Together to Reduce Violence in Neighborhoods (STRIVIN) Hub in the Kansas City Midtown area; and,

WHEREAS, Ivanhoe Neighborhood Council presented its proposal to the COMBAT Commission on May 12, 2022, and it was unanimously approved; and,

WHEREAS, a transfer is necessary to place the funds needed for this program in the proper spending account; now therefore,
