WHEREAS, the Director of Finance and Purchasing has solicited bids on Invitation to Bid No. 46-22 for the furnishing of golf course chemicals and fertilizers for use by the Parks + Rec Department; and,

WHEREAS, a total of 750 notifications were distributed and four responses were received, with two rejected as noncompliant; and,

WHEREAS, following evaluation of the bids submitted, the Directors of Finance and Purchasing and Parks + Rec recommend that the contract be divided and awarded to the vendors submitting the lowest bid for each item; and,

WHEREAS, pursuant to section 1054.6 of the Jackson County Code, the Directors of Finance and Purchasing and Parks + Rec recommend the award of twelve-month term and supply contracts for the furnishing of these items to Site One Landscape Supply of Cleveland, OH, and Van Diest Supply of Webster City, IA, under the terms and conditions of RFP No. 46-22, for the reason that they have
