WHEREAS, the Sheriff's Office has been awarded the Missouri Western Interdiction and Narcotics Task Force (MoWIN) grant in the amount of \$107,009.86 by the Missouri Department of Public Safety; and,

WHEREAS, this grant funds the vehicle allowance and salaries for two deputies assigned to the Multi-Jurisdictional Drug Task Force; and,

WHEREAS, an appropriation are necessary in order to place the grant funds in the proper spending accounts; and,

WHEREAS, the County Executive recommends said appropriation; now therefore,

BE IT ORDAINED by the County Legislature of Jackson County, Missouri, that the following appropriation from the undesignated fund balance of the 2019 Grant Fund be and hereby is made:

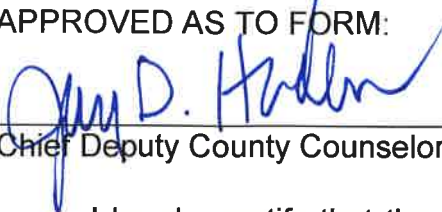

General:

1. **Governing Directives:** The Subrecipient assures that it shall comply, and all its subcontractors shall comply, with the applicable provisions of the "JAG Solicitation", the "DPS Financial and Administrative Guide", the "DPS Subrecipient Travel Guidelines", any applicable federal nondiscrimination requirements, which may include the Omnibus Crime Control and Safe Streets Act of 1968 (42 U.S.C. § 3789d); the Victims of Crime Act (VOCA) of 1984 (42 U.S.C. § 10604(e)); the Juvenile Justice and Delinquency Prevention Act (JJDP) of 2002 (42 U.S.C. § 5672(b)); the Violence Against Women (VAWA) Act of 2013 (42 U.S.C. 13925(b)(13)); Title VI of the Civil Rights Act of 1964 (42 U.S.C. § 2000d); Section 504 of the Rehabilitation Act of 1973 (29 U.S.C. § 794); Title II of the Americans with Disabilities Act of 1990 (42 U.S.C. §§ 12131-34); Title IX of the Education Amendments of 1972 (20 U.S.C. §§ 1681, 1683, 1685-86); the Age Discrimination Act of 1975 (42 U.S.C. §§ 6101-07); 28 C.F.R. Part 31 (U.S. Department of Justice Regulations – OJJDP Grant Programs); 28 C.F.R. The Compliance Training may be hosted in-person or as a webinar to provide post-award information to include, but not limited to, subaward acceptance, project implementation, reporting requirements, subaward changes, civil rights compliance, monitoring responsibilities, record retention, internal controls, and accounting responsibilities.
3. **Non-Supplanting:** The Subrecipient assures that federal and/or state funds made available under this subaward will not be used to supplant other federal, state, or local funds but will be used to increase the amount of funds that would, in the absence of these funds, be made available for the activities of this project.
4. **Change in Personnel:** The Subrecipient agrees to notify, within a timely manner, the Missouri Department of Public Safety if there is a change in or temporary absence as it affects the 'My Profile' module, 'Contact Information' form, and/or 'Budget' form within WebGrants. The notification shall be sent through the 'Correspondence' component of WebGrants to the appropriate Internal Contact with the *Change of Information Form* attached.
5. **Subaward Adjustments:** The Subrecipient understands that any deviation from the approved subaward must have prior approval from the Missouri Department of Public Safety. No additional funding shall be awarded to a Subrecipient (unless specifically notified by the Missouri Department of Public Safety of additional funding being awarded), but changes from one budget

line to another budget line may be possible if the request is allowable and within the scope of the guidelines. Prior approval must be requested via the 'Subaward Adjustment' component of WebGrants.

6. **Monitoring:** The Subrecipient agrees to maintain the records necessary to evaluate the effectiveness of the project. In addition, the Subrecipient assures that all documentation or records relating to this subaward shall be made available to monitoring representatives of the Missouri Department of Public Safety, the Office of Missouri State Auditor, the U.S. Department of Justice (DOJ), the DOJ Office of Inspector General, the Comptroller General of the United States, or any of their authorized representatives immediately upon request. The Subrecipient assures that fund accounting, auditing, monitoring, and such evaluation procedures as may be necessary to keep such records as the Missouri Department of Public Safety shall prescribe, will be provided to assure fiscal control, proper management, and efficient disbursement of funds received under this subaward.

The Missouri Department of Public Safety reserves the right to suspend or terminate grant funding pending the review of a report of fraud, waste, or abuse relating to funds under this subaward.

9. **Non-Disclosure Agreements:** The Subrecipient understands it cannot require any employee or subcontractor to sign an internal confidentiality agreement or statement that prohibits or otherwise restricts, or purports to prohibit or restrict, the reporting (in accordance with law) of waste, fraud, or abuse to an investigative or law enforcement representative of a federal department, the Missouri Department of Public Safety, or other agency authorized to receive such information.

The foregoing is not intended, and shall not be understood by the Subrecipient, to contravene requirements applicable to Standard Form 312 (which relates to classified information), Form 4414 (which relates to sensitive compartmented information), or any other form issued by a federal department or agency governing the non-disclosure of classified information.

In accepting this subaward, the Subrecipient:

- (a) Represents that it neither requires nor has required internal confidentiality agreements or statements from employees or subcontractors that currently prohibit or otherwise currently restrict (or purport to prohibit or restrict) employees or subcontractors from reporting waste, fraud, or abuse as described above; and
 - (b) Certifies that, if it learns or is notified that it is or has been requiring its employees or subcontractors to exercise agreements or statements that prohibit or otherwise restrict (or purport to prohibit or restrict), reporting of waste, fraud, or abuse as described above, it will immediately stop any further obligations of award funds, will provide prompt written notification to the Missouri Department of Public Safety, and will resume (or permit resumption of) such obligations only if expressly authorized to do so by the Missouri Department of Public Safety.
10. **Protection from Reprisal for Disclosures:** The Subrecipient understands, pursuant to 41 U.S.C § 4712, an employee or subcontractor may not be discharged, demoted, or otherwise discriminated against as a reprisal for disclosing information that the employee or subcontractor reasonably believes is evidence of gross mismanagement of the funds under this subaward, a gross waste of the funds under this subaward, an abuse of authority relating to the funds under this subaward, a substantial and specific danger to public health or safety, or a violation of law, rule, or regulation related to the funds under this subaward.
11. **Lobbying:** The Subrecipient understands and agrees that, in general, it cannot use any federal funds, either directly or indirectly, to support or oppose the enactment, repeal, modification or adoption of any law, regulation or policy, at any level of government. Furthermore, the Subrecipient understands and agrees that, in general, federal law prohibits federal funds from being used to pay any person to influence (or attempt to influence) with respect to the awarding of a federal grant or cooperative agreement.

As required by 31 U.S.C. § 1352, as implemented by 28 C.F.R. Part 69, the Subrecipient certifies and assures the following:

- (a) No federal appropriated funds may be paid, by or on behalf of the Subrecipient, to any person for influencing or attempting to influence an officer or employee of any agency, a Member of Congress, an officer or employee of Congress, or an employee of a Member of Congress in connection with the making of any federal grant, the entering into of any cooperative agreement, or the extension, continuation, renewal, amendment, or modification of any federal grant or cooperative agreement.
 - (b) If the Subrecipient's request for federal funds is in excess of \$100,000, and any funds other than federal appropriated funds have been paid or will be paid to any person for influencing or attempting to influence an officer or employee of any agency, a member of Congress, an officer or employee of Congress, or an employee of a member of Congress in connection with this federal grant or cooperative agreement, the Subrecipient shall complete and submit Standard Form – LLL, "Disclosure of Lobbying Activities" in accordance with its instructions.
12. **Fair Labor Standards Act:** All Subrecipients of federal funds will comply with the minimum wage and maximum hour's provisions of the Federal Fair Labor Standards Act.
 13. **Employment of Unauthorized Aliens:** Pursuant to Section 285.530.1 RSMo, the Subrecipient assures that it does not knowingly employ, hire for employment, or continue to employ an unauthorized alien to perform work within the State of Missouri, and shall affirm, by sworn affidavit and provision of documentation, its enrollment and participation in a federal work authorization program with respect to the employees working in connection with the contracted services. Further, the Subrecipient shall sign an affidavit affirming that it does not knowingly employ any person who is an unauthorized alien in connection with the contracted services.

In accordance with Sections 285.525 to 285.550, RSMo a general contractor or subcontractor of any tier shall not be liable when such general contractor or subcontractor contracts with its direct subcontractor who violates subsection 1 of Section 285.530, RSMo if the contract binding the contractor and subcontractor affirmatively states that the direct subcontractor is not knowingly in violation of subsection 1 of Section 285.530, RSMo and shall not henceforth be in such violation and the contractor or subcontractor receives a sworn affidavit under the penalty of perjury attesting to the fact that the direct subcontractor's employees are lawfully present in the United States.
 14. **Relationship:** The Subrecipient agrees that they will represent themselves to be an independent Subrecipient offering such services to the general public and shall not represent themselves or their employees to be employees of the Missouri Department of Public Safety. (This provision is not applicable to the Missouri Department of Public Safety or any of its divisions or programs.) Therefore, the Subrecipient shall assume all legal and financial responsibility for taxes, FICA, employee fringe benefits, workers' compensation, employee insurance, minimum wage requirements, overtime, etc.
 15. **Texting While Driving:** Pursuant to Executive Order 13513, "Federal Leadership on Reducing Text Messaging While Driving," 74 Fed. Reg. 51225 (October 1, 2009), the Missouri Department of Public Safety encourages the Subrecipient to adopt and enforce policies banning employees from text messaging while driving any vehicle during the course of performing work funded by

this subaward, and to establish workplace safety policies and conduct education, awareness, and other outreach to decrease crashes caused by distracted drivers.

16. **Drug-Free Workplace:** As required by the Drug-Free Workplace Act of 1988, as implemented at 28 C.F.R. Part 83, Subpart F, as defined by 28 C.F.R. §§ 83.620 and 83.650:

The Subrecipient certifies and assures that it will, or will continue to, provide a drug-free workplace by:

- (a) Publishing a statement notifying employees that the unlawful manufacture, distribution, dispensing, possession, or use of a controlled substance is prohibited in its workplace and specifying the actions that will be taken against employees for violation of such prohibition;
- (b) Establishing an on-going drug-free awareness program to inform employees about:
 - (1) The dangers of drug abuse in the workplace;
 - (2) The Subrecipient's policy of maintaining a drug-free workplace;
 - (3) Any available drug counseling, rehabilitation, and employee assistance programs; and
 - (4) The penalties that may be imposed upon employees for drug abuse violations occurring in the workplace;
- (c) Making it a requirement that each employee to be engaged in the performance of work funded by this subaward be given a copy of the statement required by paragraph (a);
- (d) Notifying the employee in the statement required by paragraph (a) that, as a condition of employment funded by this subaward, the employee will:
 - (1) Abide by the terms of the statement; and
 - (2) Notify the employer in writing of the employee's conviction for a violation of a criminal drug statute occurring in the workplace no later than five (5) calendar days after such conviction;
- (e) Notifying the Missouri Department of Public Safety, in writing, within 10 calendar days after receiving notice under subparagraph (d)(2) from an employee or otherwise receiving actual notice of such conviction. Subrecipients of convicted employees must provide notice, including position title of any such convicted employee, to the Missouri Department of Public Safety by one of the following methods:

- (f) Taking one of the following actions, within 30 calendar days of receiving notice under subparagraph (d)(2), with respect to any employee who is convicted:
 - (1) Taking appropriate personnel action against such an employee, up to and including termination, consistent with the requirements of the Rehabilitation Act of 1973, as amended; or

- (2) Requiring such employee to participate satisfactorily in a drug abuse assistance or rehabilitation program approved for such purposes by a federal, state, or local health, law enforcement, or other appropriate agency; and
- (g) Making a good faith effort to continue to maintain a drug-free workplace through implementation of paragraphs (a), (b), (c), (d), (e), and (f).

Civil Rights:

1. **Ensuring Access to Federally Assisted Programs:** The Subrecipient acknowledges that federal laws prohibit recipients of financial assistance from discriminating on the basis of race, color, national origin, religion, sex, or disability in funded programs or activities, not only in respect to employment practices but also in the delivery of services or benefits. 8. **Discrimination in Public Accommodations:** The Subrecipient assures compliance with Section 213.065 RSMo in regards to non-discrimination in public accommodations as it relates to accommodations, advantages, facilities, services, or privileges made available in place of public accommodations.

Financial:

1. **Fund Availability:** The Subrecipient understands all subawards are subject to the availability of appropriated funds and any modifications or additional requirements that may be imposed by law. It is understood and agreed upon that, in the event funds from federal and/or state sources are not appropriated and continued at an aggregate level sufficient to cover the costs under this subaward, or in the event of a change in federal and/or state law relevant to these costs, the obligations of each party hereunder shall thereupon be terminated immediately upon receipt of written notice.
2. **Release of Funds:** The Subrecipient acknowledges no funds will be disbursed under this subaward until such time as all required documents are signed by the Subrecipient Authorized Official and Subrecipient Project Director and returned to the Missouri Department of Public Safety for final review and signature by the Director or his/her designee.
3. **Duplicative Funding:** The Subrecipient agrees that if it currently has an open award of federal and/or state funds or if it receives an award of federal and/or state funds other than this subaward, and those award funds have been, are being, or are to be used, in whole or in part, for one or more of the identical cost items for which funds are being provided under this subaward, the Subrecipient will promptly notify, in writing, the Missouri Department of Public Safety. If so requested and allowed by the Missouri Department of Public Safety, the

Subrecipient shall submit a Subaward Adjustment for a budget revision or program revision to eliminate any inappropriate duplication of funding.

4. **Financial Guide:** The Subrecipient agrees to comply with the financial and administrative requirements set forth in the current edition of the Office of Justice Programs (OJP) Financial Guide.

7. **Project Income:** The Subrecipient agrees to account for project income generated by the activities of this subaward, and shall report receipts and expenditures of this income on the monthly Claim report. The Subrecipient understands that all project income generated as a result of this subaward shall be expended during the life of the project period, unless otherwise stated.
8. **Procurement:** The Subrecipient assures that all procurement transactions whether negotiated or competitively bid and without regard to dollar value shall be conducted in a manner to provide maximum open and free competition. In addition, the Subrecipient assures that all procurement transactions will meet the minimum standards set forth in the "DPS Financial and Administrative Guidelines" and identified here:
 - (a) All quotations and the rationale behind the selection of a source of supply shall be retained, attached to the purchase order copy, and placed in the accounting files.
 - (b) Purchases to a single vendor totaling less than \$3,000 may be purchased with prudence on the open market.
 - (c) Purchases estimated to total between \$3,000 but less than \$25,000 to a single vendor, must be competitively bid, but need not be solicited by mail or advertisement.
 - (d) Purchases with an estimated total of \$25,000 or over to a single vendor shall be advertised for bids in at least two daily newspapers of general circulation in such places as are most likely to reach prospective bidders at least five days before bids for such purchases are to be opened.
 - (e) Where only one bid or positive proposal is received, it is deemed to be sole source procurement.

- (f) Sole source procurement on purchases to a single vendor of \$3,000 and over requires prior approval from the Missouri Department of Public Safety.

 - (c) Have not within a three-year period preceding this subaward been convicted of a felony criminal violation under any federal law, unless such felony criminal conviction has been disclosed in writing to the Department of Justice at ojpcompliancereporting@usdoj.gov, and, after such disclosure, the Subrecipient has received a specific written determination from the Department of Justice that neither suspension nor debarment of the Subrecipient is necessary to protect the interests of the Government in this case;
 - (d) Are not presently indicted for or otherwise criminally or civilly charged by a governmental entity (federal, state, tribal, or local) with commission of any of the offenses enumerated in paragraph (b) of this certification; and/or
 - (e) Have not within a three year period preceding this subaward had one or more public transactions (federal, state, tribal, or local) terminated for cause or default.

4. **Custodial Interrogations:** The Subrecipient assures, where the project agency is a law enforcement agency, that the law enforcement agency is in compliance with the state provisions of Section 590.700 RSMo relating to custodial interrogations and has adopted a written policy to

record custodial interrogations of persons suspected of committing or attempting to commit the felony crimes described in subsection 2 of this section.

5. **DWI Law – Law Enforcement:** The Subrecipient assures, where the project agency is a law enforcement agency, that the law enforcement agency is in compliance with the state provisions of Section 43.544 RSMo relating to the “DWI Law” and has adopted a written policy to forward arrest information for all intoxication-related traffic offenses to the central repository as required by Section 43.503 RSMo.
6. **DWI Law – Prosecutors:** The Subrecipient assures, where the project agency is a county prosecutor’s office or municipal prosecutor’s office, that the county prosecutor’s office or municipal prosecutor’s office is in compliance with Section 43.544 RSMo relating to the “DWI Law” and has adopted a written policy to forward all charge information for intoxication-related traffic offenses to the central repository as required by Section 43.503 RSMo.
7. **Data Reporting Requirements:** The Subrecipient agrees to complete and submit any data or statistical reports required for this program as outlined in the “JAG Solicitation”. Failure to submit reports by the deadline dates may result in delay for reimbursement requests and/or cancellation of the subaward.
8. **Time Records Requirement:** The Subrecipient assures that, all project personnel funded through this subaward will maintain timesheets that detail 100% of their time along with the activities/services provided. The timesheets should be signed by both the employee and the appropriate approving official. These timesheets must be provided to the Missouri Department of Public Safety personnel upon request.
9. **Body Armor:** The Subrecipient understands, if monies are requested and awarded for the purchase of body armor, that JAG funds may be used to purchase body armor but may not be used as the 50% match for purposes of BJA’s Bulletproof Vest Partnership (BVP) Program. Subrecipient will be required to forward a copy of such policy(s) to the Missouri Department of Public Safety at the time of acceptance of the subaward.

13. **Criminal Intelligence Systems:** The Subrecipient agrees that any information technology system funded or supported by OJP funds will comply with 28 C.F.R. Part 23, Criminal Intelligence Systems Operating Policies, if OJP determines this regulation to be applicable. Should OJP determine 28 C.F.R. Part 23 to be applicable, OJP may, at its discretion, perform audits of the system, as per the regulation.

16. **Mitigation Plan:** The Subrecipient agrees to fully comply with the Missouri Department of Public Safety's *Mitigation Plan for Clandestine Methamphetamine Laboratory Enforcement Operations*, where such grant-funded project is for a drug task force. No monies from this subaward may be obligated to support methamphetamine lab operations unless the Subrecipient agrees to this special condition and fully participates in implementation of the *Mitigation Plan*.
17. **NEPA:** The Subrecipient agrees to assist BJA in complying with the National Environmental Policy Act (NEPA), the National Historic Preservation Act, and other related federal environmental impact analyses requirements in the use of these grant funds, either directly or indirectly. I. Introduction

A. This plan was developed by the Missouri Department of Public Safety (DPS) in cooperation with the Missouri State Highway Patrol (MSHP) and the Missouri Department of Natural Resources (DNR). The basis for this plan is Missouri's existing Clandestine Drug Laboratory Collection Station program, which was developed by Missouri state and local officials in cooperation with the Federal Environmental Protection Agency (EPA) and the Federal Drug Enforcement Administration (DEA).

B. The scope of application for this plan is all DPS-funded law enforcement operations involving clandestine methamphetamine laboratories (CMLs).

C. The purpose of this plan is to:

(1) Coordinate mitigation of the adverse environmental, health, and safety impacts that may arise from law enforcement operations involving CMLs; and

(2) Establish the process and points of accountability for ensuring that CML enforcement operations are conducted in compliance with applicable federal, state, and local environmental, health, and safety laws.

II. DPS Accountability

A. On each grant administered by DPS that funds CML enforcement operations, DPS will:

(1) Require compliance with this plan as a condition of the grant award; and

(2) Monitor compliance with this plan.

B. DPS will administer available grant funds in a manner that facilitates compliance with this plan.

III. Law Enforcement Accountability

A. When a juvenile is discovered at the site of a CML enforcement operation and it is appropriate to place the juvenile into protective custody pursuant to section 210.125, RSMo, a juvenile officer will be promptly contacted and requested to take the juvenile into protective custody to provide for the potential health needs of the juvenile, including medical testing for methamphetamine toxicity and follow-up medical tests, examinations, or health care necessary as a result of methamphetamine toxicity.

B. All personnel participating in the clean up and/or disposal of a CML will receive:

(1) Medical screening required by Occupational Safety and Health Administration (OSHA) regulation 29 CFR 1910.120, as applicable pursuant to EPA regulation 40 CFR 311;

(2) Initial and refresher training required by OSHA regulation 29 CFR 1910.120, as applicable pursuant to EPA regulation 40 CFR 311;

(3) Personal protective equipment required by OSHA regulation 29 CFR 1910.120, as applicable pursuant to EPA regulation 40 CFR 311.

C. Upon the seizure of a CML:

(1) An DEA Form 612 will be completed; and

(2) An initial contamination assessment will be conducted by an individual trained to recognize environmental hazards associated with CMLs. Such training will, at a minimum, consist of training pursuant to paragraph III.G of this plan.

D. If any sign of significant environmental contamination is detected during the initial contamination assessment; if possible, a COPS number will be obtained from and a DEA contractor will be engaged to complete a comprehensive contamination report and to remove all non-evidentiary materials associated with the CML.

E. When a DEA contractor is not engaged to remove materials from the site of a CML enforcement operation, a person trained pursuant to paragraph III.G of this plan will segregate CML materials at the site into:

(1) Evidence to be collected; and

(2) Non-evidentiary materials to be removed to a collection station authorized and regulated by DNR.

F. The removal of CML materials to a collection station will be performed by a DEA contractor or an individual trained to perform the removal pursuant to paragraph III.G of this plan.

G. The provisions of paragraphs III.C, III.E, III.F and IV.B of this plan will be performed by persons trained to carry out those provisions as follows:

(1) An initial 40-hour Clandestine Laboratory Certification Training, or equivalent training;

(2) Field supervised training of 24 hours; and

(3) Refresher training of 8 hours annually.

IV. Collection Station Accountability

A. In order to be used under this plan, a collection station must be issued by DPS and authorized for use by DNR.

B. All operations at a collection station will be performed by a person who has received collection station operator training from DNR in addition to training pursuant to paragraph III.G of this plan.

C. All materials removed to a collection station will be segregated by hazard class, packaged, marked, labeled, dated, and processed to determine the appropriate waste stream for disposal.

D. All hazardous waste collected at a collection station will be removed by a licensed hazardous waste hauler under a properly executed manifest and will be transported for disposal at either a Missouri certified resource recovery facility or a temporary storage and disposal facility permitted to accept hazardous waste.

V. DNR Accountability

A. DNR will monitor the transport and disposal components of section IV of this plan for compliance with applicable federal, state, and local law.

B. DNR will provide technical assistance and, as available, financial assistance to maintain collection stations utilized pursuant to this plan.

C. When site contamination is indicated by a comprehensive contamination report completed pursuant to paragraph III.D of this plan, DNR will assess the site for contamination and, if contamination is confirmed, implement the Hazardous Substance Emergency Response Plan portion of the State Emergency Operation Plan pursuant to sections 260.500 through 260.552, RSMo.

MoWIN is comprised of twenty-nine (29) members. Thirteen (13) of them are JAG funded positions within the Drug Task Force and are made up from the following agencies; Kansas City, Missouri Police Department BOPC has two (2) positions, Clay County Sheriff's Department has five (5) positions, Platte County Sheriff's Office has four (4) positions, and the Jackson County Sheriff's Office has two (2) positions. The remaining

sixteen (16) positions are funded by the Drug Enforcement Administration (1), Kansas City, Missouri Police Department BOPC (10), Clay County Sheriff's Office (1), HIDTA (3) and the Missouri Army National Guard (1).

The MoWIN Drug Task Force is divided into two categories. The first category is the Interdiction side, the second is the Non-Interdiction side. The Interdiction side has twenty-one (21) committed members and the Non-Interdiction side has seven (7) full-time detectives and one (1) part-time detective.

Interdiction is responsible for interdicting the flow of illegal narcotics, contraband, or wanted fugitives as they attempt to travel or be sent through the metropolitan Kansas City, Missouri area. Interdiction efforts are focused on methods of transportation such as bus, train, highway and plane. Additionally, emphasis is placed on companies and entities that ship parcels. Interdiction works with the DEA, HSI, and the USPIS on a daily basis. Interdiction is responsible for preparing case files and charges for those caught smuggling or possessing narcotics and conducting follow-up investigations (when possible) surrounding smuggled narcotics determined to be destined for the Kansas City, metropolitan area.

Non-Interdiction is responsible for processing all field possession arrests made by the municipal officers whose parent agencies fall within the jurisdictional boundaries of Jackson, Platte, Clay and Caldwell counties. Non-Interdiction is responsible for conducting undercover drug buys, following up on tips about drug houses, and executing search warrants on those homes identified as being involved in illegal narcotics activity.

Both Interdiction and Non-Interdiction share responsibilities of community involvement, drug education and prevention efforts. Both are active in Veterans' Court, Drug Court, community meetings, drug take-backs, drug awareness and education programs for both law enforcement officers and civilians. All MoWIN members are expected to be readily available for overtime extending beyond their shift or to handle "call-back" situations surrounding narcotics investigations. The following 13 positions are requesting funds to be retained.

BOPC-TFO A.W. has been in the Interdiction Section since September of 2015. BOPC-TFO A.W. duties are to interdict the flow of narcotics and contraband as it flows through the Kansas City, Missouri metropolitan area and prepare/present prosecutable case files for prosecution. BOPC-TFO A.W. will also be responsible for providing narcotics education to community groups, law enforcement agencies, various surveillances and DEA sponsored drug take-backs. Prior to coming to the Interdiction Section, BOPC-TFO A.W. spent 2 and a half years in the Financial Investigations Section. BOPC-TFO A.W. also spent 7 years as an undercover narcotics detective in the Drug Enforcement Unit. BOPC-TFO A.W.'s prior training includes 4 years of service in the United States Army. BOPC-TFO A.W. obtained a Top Secret clearance and worked in Military Intelligence as a voice interceptor. BOPC-TFO A.W. acquired proficiency in the Spanish language as part of his military training. BOPC-TFO A.W. is POST certified and attended SkyNarc (INIA) training in June of 2016 and Operation Pipeline in December of 2017. His duties will be conducting interdiction efforts in public transit systems and parcels.

BOPC-TFO B.R. has been in the Interdiction Unit since 2009 and works all forms of public transit through Kansas City as well as parcel companies. BOPC-TFO B.R. duties will be to interdict the flow of narcotics and contraband as it flows through the Kansas City, Missouri metropolitan area and prepare/present prosecutable case files for prosecution. BOPC-TFO B.R. will also be responsible for providing narcotics education to community groups, law enforcement agencies, various surveillances, and DEA sponsored drug take-backs. BOPC-TFO B.R. is a former Violent Crimes detective and brought his ideas and interview skills to the unit. BOPC-TFO B.R. has traveled to the main sort facilities in the United States and was trained by interdiction officers in parcel interdiction. He used this training to then assist in the formation of a full time parcel squad within the Interdiction Unit. BOPC-TFO B.R. is POST certified and attended the SkyNarc (INIA) interdiction training certification in 2010, 2011, 2012 and 2015.

CCDTF-TFO A.B. began a law enforcement career in 2005. CCDTF-TFO A.B. completed basic training at the Missouri Western State University Law Enforcement Academy in St. Joseph, MO, where she graduated with a Class A license from the Department of Public Safety. Interdiction of MoWIN is responsible for maintaining coverage of a public transit system that operates on a twenty-four hour (24), daily schedule, 365 days a year. For officer safety issues, a minimum of four (4) detectives is required when working a transit system. Trying to accomplish this mission without overtime compensation reduces the impact of this task force and the positive effects on society that occurs when narcotics, contraband, and fugitives are taken into police custody as a direct result of the interdiction contact.

Interdiction detectives work their normal tour of duty and respond back to all tips provided by public transit and/or private parcel and freight investigative sources. Interdiction detectives vary the times that they arrive and depart these modes of public transit, working late nights and/or weekends in an effort to disrupt or confuse those narcotics couriers that carefully plan their "transportation runs" in an effort to go undetected by law enforcement personnel. In the past, when varying times and shifts of interdiction, some arrestees have advised detectives they had specifically designed their trip to arrive late at night or on a holiday or weekend believing that the police would not be working. This is a valuable tool that should not be underestimated. Without the use of overtime, a large majority of the transit schedules would go unobserved and many positive interdiction encounters would not occur.

BOPC-TFO A.G. duties interdict the movement of narcotics and contraband as they flow through the Kansas City, Missouri metropolitan area and thus presenting prosecutable case files for prosecution. BOPC-TFO A.G. also is responsible for providing narcotics education to community groups, law enforcement agencies, various surveillances, drug sweeps and DEA sponsored drug take-backs. BOPC-TFO A.G. has been in the interdiction unit since 2002. BOPC-TFO A.G. is currently a K-9 handler within the interdiction squad and works all forms of public transit through Kansas City as well as parcel companies. BOPC-TFO A.G. was responsible for forming the existing parcel squad within the Interdiction Unit. BOPC-TFO A.G. traveled to the main UPS sort facility in Louisville, Kentucky with BOPC-TFO B.R. and was trained on parcel interdiction. BOPC-TFO K.E. is a supervisor and may not be required to stay as late or return to work from on-call status which allows for his requested hours to be lower than the detectives.

BOPC-TFO M.W. interdicts the movement and contraband as it flows through the Kansas City, Missouri metropolitan area and prepares/presents prosecutable case files for prosecution. BOPC-TFO M.W. also is responsible for providing narcotics education to community groups, law enforcement agencies, various surveillances, and DEA sponsored drug take-backs. BOPC TFO-M.W. has been with the Kansas City MO Police Department since 2001. He attended the Regional Police Academy from March 2001 until September 2001. He performed the duties of a patrol officer from September of 2001 until May 2004. From May 2004 until February 2006, he was assigned to the Street Narcotics Unit in an undercover capacity where he purchased street level narcotics. In February 2006, he returned to a patrol assignment for a few months. In May 2006, he transferred to the Assault Squad as a detective. BOPC-TFO M.W. remained in the Assault Squad until September 2009. During that time, BOPC-TFO M.W. was also assigned to the Police Shooting Team and was responsible for investigating officer involved shootings. He was also made a member of the Metro Squad, which was a multi-jurisdictional task force responsible for assisting other departments with large scale investigations. In September 2009, he transferred to a patrol assignment where he remained until November of 2011. During that time, he was a proactive officer with the Target Oriented Police Squad. In November 2011, he transferred to Shoal Creek Property Crimes where he served as a detective. In February 2013, he transferred to the Illegal Firearm Squad where he investigated gun and narcotic related crimes. BOPC-TFO M.W. remained in the Illegal Firearm Squad until he was transferred to his current assignment with the Interdiction Unit. He is POST certified. BOPC-TFO M.W. was assigned to the MoWIN Drug Task Force in March 2018 and will soon be enrolled in the Basic and Advanced Narcotics Investigators Course. BOPC-TFO M.W. is requesting to receive **138.5 hours** of paid overtime for the 2018-2019 JAG Grant year. The overtime funding will pay for BOPC-TFO M.W. to stay past or respond after normal business hours to conduct interdiction related activities. The funding will also be spent on overtime expenses related to participating in education, prevention, and training efforts including the National DEA drug take-backs efforts twice annually. BOPC-TFO M.W.'s base salary is paid by the BOPC. BOPC-TFO M.W. is a canine handler and is often times called out or is required to work later than other members due to his canine responsibilities. Therefore he is requesting slightly more hours than his team members to offset the additional expense.

BOPC-TFO R.G. supervises the interdiction of narcotics and contraband in the Kansas City, Missouri metropolitan area and prepares/presents case files for prosecution. BOPC-TFO R.G. also is responsible for providing narcotics education to community groups, law enforcement agencies, various surveillances and DEA sponsored drug take-backs. BOPC-TFO R.G. has been with Kansas City Police Department since 1994. BOPC-TFO R.G. attended the Regional Police Academy from September 1994 until March 1995. BOPC-TFO R.G. performed the duties of a patrol officer from March 1995 until March 1998. During that time, he served as a FTO and in a proactive squad titled PACT. From March 1998 until February 2002, BOPC-TFO R.G. served as a motorcycle officer in the Traffic Enforcement Unit. In February 2002, BOPC-TFO R.G. was assigned to the Street Narcotics Unit in an undercover capacity where he purchased street level narcotics. BOPC-TFO R.G. remained in that capacity until being reassigned to the Drug Enforcement Unit in May 2005. BOPC-TFO R.G. served the Drug Enforcement Unit by purchasing large scale narcotics until July 2005. In July 2005, BOPC-TFO R.G. was transferred to the Intelligence Unit where he remained until being promoted to the rank of Sergeant in June 2007. After his promotion, BOPC-TFO R.G. was transferred to South Patrol Division where he served as a supervisor for the front-line police officer. BOPC-TFO R.G. remained in that role until May 2010, when he was reassigned to the South Patrol Property Crimes Unit. BOPC-TFO R.G. served in Property Crimes until March 2016, when he was transferred to his

current assignment with Interdiction Unit as the OIC of the MoWIN Drug Task Force. BOPC-TFO R.G. is POST certified and is responsible for supervising the detectives assigned to the MoWIN Task force and other OIC duties. BOPC-TFO R.G. is requesting to receive **55 hours** of paid overtime for the 2018-2019 JAG Grant year. The overtime funding will pay for BOPC-TFO R.G. to stay past or respond after normal business hours to conduct interdiction or supervision related activities. The funding will also be spent on overtime expenses related to participating in education, prevention, and training efforts including the National DEA drug take-back efforts twice annually. BOPC-TFO R.G.'s base salary is paid by the BOPC. BOPC-TFO R.G. is a supervisor and may not be required to stay as late or return to work from on-call status which allows for his requested hours to be lower than the detectives.

BOPC-TFO Y.A. interdicts the movement of narcotics and contraband as it flows through the Kansas City, Missouri metropolitan area and prepares/presents case files for prosecution. BOPC-TFO Y.A. also is responsible for providing narcotics education to community groups, law enforcement agencies, various surveillances, drug sweeps, and DEA sponsored drug take-backs. BOPC-TFO Y.A. has been with the Kansas City, Missouri Police Department since October 1997 when he was appointed to Regional Police Academy. He graduated in April 1998 with his POST certification and was assigned to Central Patrol Division where he remained until February 2002 when he was transferred to the Narcotics and Vice Division. Since his assignment to Narcotics and Vice in 2002, he has served as an undercover detective with the Street Narcotics Unit, detective in Drug Enforcement Unit, and a detective in the Metro Meth Task Force before being transferred to the Interdiction Unit in 2016 where he remains today. BOPC-TFO Y.A. is also a certified K-9 handler by NPCA and attended the three-week canine handler's course at Vohne Liche Kennels, Denver, Indiana 2017. BOPC-TFO Y.A. is requesting to receive **138.5 hours** of paid overtime for the 2018-2019 JAG Grant year. The overtime funding will pay for him to stay past or respond after normal business hours to conduct interdiction related activities. The funding will also be spent on overtime expenses related to participating in education, prevention, and training efforts including the National DEA drug take-back efforts twice annually. BOPC-TFO Y.A. is a canine handler and is often times called out or is required to work later than other members due to his canine responsibilities. Therefore he is requesting slightly more hours than his team members to offset the additional expense.

The TFO's from Clay County assigned to the Non-Interdiction Side are made up of (1) Supervisor and (3) detectives. They are **CCDTF-TFO A.B.**, **CCDTF-TFO C.J.**, **CCDTF-TFO M.C.**, and **CCDTF-TFO R.G.**. They are responsible for undercover operations and narcotics investigations which consist of, but are not limited to narcotic purchases, handling of informants, applying for, executing, and processing search warrants, and assisting other agencies with the interviewing of offenders and filing the appropriate case files for prosecution. Detectives will be on call twenty-four hours (24), 365 days a year to cover the narcotic investigation needs of all local municipalities within the Clay, Platte, Jackson, and Caldwell Counties. The detectives have varying schedules in regards to operational times in an attempt to disrupt criminal activity. This group is assisting the partnering agencies with interviews, evidence handling, and charges-all of which have increased drastically over the past few years. The personnel share on-call status and routinely take as many as 7 to 8 additional narcotic cases after their regular duty hours and on their leave days. With the continually increasing case load, the group will need additional funding to cover any overtime incurred.

TFO's assigned to the Non-Interdiction side of MoWIN **CCDTF-TFO A.B.**, **CCDTF-TFO C.J.**, **CCDTF-TFO R.G.**, & **CCDTF-TFO M.C.** **CCDTF-TFO A.B.** is requesting **93.8 hours** of paid overtime. **CCDTF-TFO C.J.** is requesting **86.6 hours** of paid overtime. **CCDTF-TFO M.C.** is requesting **93.3 hours** of paid overtime. **CCDTF-TFO R.G.** is requesting **91.0 hours** of paid overtime. The overtime funding will pay for the members to respond before or after normal business hours to assist with narcotics related activities, education and prevention efforts, and assisting municipalities within Clay County with investigating and charging field possession arrests that may occur any time of the night or day. Their experience and certifications as it relates to the proposed project is included in the Personnel Budget Category listed above.

The TFO assigned to MoWIN Interdiction from **CCDTF-TFO P.W.** is requesting to receive **93.82 hours** of paid overtime for the 2018-2019 JAG Grant year. The overtime funding will pay for CCDTF-TFO P.W. to stay past or respond after normal business hours to conduct interdiction related activities. The funding will also be spent on overtime expenses related to participating in education, prevention, and training efforts including the National DEA drug take-back efforts twice annually. His experience and certifications as they relate to the proposed project are included in the Personnel Budget Category listed above.

The Jackson County TFO's **JACO-TFO D.A.** & **JACO-TFO R.P.** are assigned to MoWIN Interdiction which is responsible for maintaining coverage of a public transit system that operates on a twenty-four hour (24), daily schedule, 365 days a year. For officer safety issues, a minimum of four (4) detectives is required when working a transit system. Trying to accomplish this mission without overtime compensation reduces the impact of this task force and the positive effects on society that occurs when narcotics, contraband, and fugitives are taken into police custody as a direct result of the interdiction contact.

Interdiction detectives work their normal tour of duty and respond back to all tips provided by public transit and/or private parcel and freight investigative sources. Interdiction detectives vary the times that they arrive and depart these modes of public transit, working late nights and/or weekends in an effort to disrupt or confuse those narcotics couriers that carefully plan their "transportation runs" in an effort to go undetected by law enforcement personnel. In the past, when varying times and shifts of interdiction, some arrestees have advised detectives they had specifically designed their trip to arrive late at night or on a holiday or weekend believing that the police would not be working. This is a valuable tool that should not be underestimated. Without the use of overtime, a large majority of the transit schedules would go unobserved and many positive interdiction encounters would not occur.

JACO-TFO D.A. & JACO-TFO R.P. are each requesting to receive **81.54 hours** of paid overtime for the 2018-2019 JAG Grant Year. The overtime funding will pay for them to stay past or respond after normal business hours to conduct interdiction related activities. The funding will also be spent on overtime expenses related to participating in education, prevention, and training efforts including the National DEA drug take-back efforts twice annually. Their experience and certifications as it relates to the proposed project is included in the Personnel Budget Category listed above.

Platte County Missouri is surrounded by increasing high drug crime areas such as Kansas City, Kansas to the south, Leavenworth, Kansas to the west, St. Joseph Missouri to the north and Kansas City, Missouri, which city limits cover approximately half of Platte County and border the county to the east. The cities of Kansas City, Kansas and Kansas City, Missouri have been proven to be major bulk narcotics storage locations, making large quantities of narcotics easily attainable at a reduced price. Bulk narcotics historically flow from south to north, placing Platte County, Missouri directly in the north/south narcotics smuggling pipeline. The cities of Kansas City, Missouri and Kansas City, Kansas are positioned directly in the center of the United States making these locations and the surrounding areas such as Platte County very susceptible to drug crimes. Platte County, Missouri is typical in that narcotics flow from south to north, but in recent years, Platte County has proven to be non-typical in that Interstate 29 runs from north to south through the center of the United States and directly through Platte County. Narcotics traffickers from Oregon, Washington, Colorado, and California have now discovered that by traveling east on Interstate 80 to Interstate 29 south, they can avoid the Highway Interdiction teams in the state of Kansas and ultimately successfully deliver more narcotics to the Midwest and points east.

Due to the proximity of bulk narcotics to Platte County, the common flow of narcotics from south to north through Platte County and the non-typical narcotics flow from north to south through Platte County, the need for highly trained and skilled narcotics detectives is crucial to fighting this growing problem. Platte County narcotics detectives assigned to MoWIN's Non-Interdiction side are responsible for assisting Patrol deputies with these highway interdiction investigations which many times include bulk narcotics, with multiple suspects, from multiple states. These factors make conducting thorough and complete investigations very time consuming for these detectives. These cases create additional needs concerning the handling of bulk narcotics, jail space, and prosecutor needs.

In addition to assisting patrol deputies, Platte County MoWIN detectives are responsible for supporting eleven smaller communities with combating narcotics activity in Platte County. Platte County MoWIN detectives also conduct undercover operations, which require the handling and supervision of confidential informants. Platte County detectives are responsible for responding to narcotics related tips provided by citizens and other law enforcement agencies in the County. Platte County is home to the Kansas City International Airport which brings an element of narcotics related crime involving high volumes of air cargo which are often used as narcotics smuggling methods. Platte County detectives are responsible for obtaining and serving search warrants, conducting knock and talks, appearing in court, maintaining case files and Confidential Informant files.

The TFO's assigned to the Non-Interdiction side of MoWIN from the Platte County Sheriff's Office are PCMEG-TFO B.H., PCMEG-TFO B.M. **PCMEG-TFO B.H.** is requesting **171.5 hours** of paid overtime. **PCMEG-TFO B.M.** is requesting **175.25 hours** of paid overtime. The overtime funding will pay for the members to respond before or after normal business hours to assist with narcotics related activities, education and prevention efforts, and assisting municipalities within Platte County with investigating and charging field possession arrests that may occur any time of the night or day. Their experience and certifications as they relate to the proposed project are included in the Personnel Budget Category listed above.

PCMEG-TFO C.S. of the Interdiction Side of MoWIN is requesting to receive **51.5 hours** of paid overtime for the 2018-2019 JAG Grant year. The overtime funding will pay for PCMEG-TFO C.S. to stay past or respond after normal business hours to conduct Interdiction related activities. The funding will also be spent on overtime expenses related to participating in education, prevention, and training efforts including the National DEA drug take-backs efforts twice annually. PCMEG-TFO C.S. experience and certifications as they relate to the proposed project are included in the Personnel Budget Category listed above. PCMEG-

TFO C.S. is requesting fewer overtime hours than the other PCMEG-TFO's due to him being assigned to the interdiction side of MoWIN and having availability to OCDETF funds as a result of federal investigations.

PCMEG-TFO M.C., a supervisor with Platte County Sheriff's Office, is requesting **168.5 hours** of paid overtime for the 2018-2019 JAG Grant year. The overtime funding will pay for the member to respond before or after normal business hours to assist with narcotics related activities, education and prevention efforts, and assisting municipalities within Platte County with investigating and charging field possession arrests that may occur any time of the night or day. PCMEG-TFO M.C. experience and certifications as they relate to the proposed project are included in the Personnel Budget Category listed above.

Vehicle Leases

Clay County Drug Task Force (CCDTF) - Clay County Deputies are requesting two (2) lease vehicles to be used in an undercover capacity. The vehicles are the detective's only form of transportation and will be used in undercover buys and day-to-day operations in surveillance.

Jackson County Sheriff's Office (JCSO) - Transportation entails the use of (2) lease vehicles that enable the detective to respond to many different locations on a daily basis. There are no other vehicles available for the (2) detectives to operate.

The task force now covers a total of 1882 square miles with over one million citizens. It is important that all the detectives are in unmarked vehicles that blend into their surroundings to aid in concealing their identities and daily operations. The Jackson County Sheriff's Office and the Clay County Sheriff's Office do not have the surplus of vehicles necessary to outfit each of their detectives with a mechanically sound "slick" car to perform their daily duties of surveillance and undercover operations. The leasing option fulfills that need.

The Missouri Western Interdiction and Narcotics (MoWIN) Task Force was developed in 2015. Members realized the need to combine their resources to properly address drug trends and offenses which cross jurisdictional boundaries in the four counties served by MoWIN. MoWIN has combined the following Task Forces: the Kansas City Multi-Jurisdictional Task Force (KCMJTF), Clay County Drug Task Force (CCDTF) and Platte County Multi-Jurisdictional Enforcement Group (PCMEG).

Prior to the formation of the MoWIN Task Force in 2015, the Kansas City Multi-Jurisdictional Task Force, Clay County Drug Task Force, and Platte County Drug Task Force all existed individually for more than twenty years. Since 2015, these three task forces, along with members of the Caldwell County Sheriff's Department, are now combined to provide resources in a unique way. Prior to the existence of the MoWIN Task Force, the aforementioned separate task forces completed investigations independent of each other and often overlapped jurisdictional boundaries. The formation of the MoWIN Task Force has allowed for each individual task force to combine into one single task force and has resulted in a larger pool of resources, increased information sharing, and amplified productivity throughout the region. It has allowed for direct communication between the agencies during daily interaction with each other. The Drug Task Force (DTF) has established relationships between the detectives, sergeants, and commanders of the four jurisdictions blended into a single DTF. It also provides a direct line of communication between its members, allowing necessary support to be immediately put into place, allowing its members to have a more positive and efficient result to the community.

The greater Kansas City, Missouri area has seen a continued influx of drug trafficking, use and sales. This mirrors similar situations being experienced across the nation. The task force continues to see narcotics being smuggled across the United States with Kansas City, Missouri being either a final destination or a pass through for them. Many of the narcotics are coming from source cities in the southwest portions of the United States and states where it is legal to grow, possess, or use marijuana. Many of the assaults, robberies, and homicides in the metropolitan area are believed to surround trafficking or sale of illegal narcotics. Through continuing education, media outlets, and informational bulletins, we have become aware of increasing numbers of drug overdoses and deaths surrounding the opioid crisis that seems to be plaguing the nation. MoWIN has seen an increase of fentanyl during interdiction efforts. Missouri Western Interdiction and Narcotics (MoWIN) experienced an unprecedented increase in recovered fentanyl. Where only a minimal amount of grams of fentanyl had been recovered in the 2015-2016 JAG Grant year, MoWIN interdicted 41 pounds of it during the 2016-2017 JAG Grant year.

Many of the drug investigations are complex and require additional hours of labor from MoWIN detectives. It is essential to keep staffing as high as possible to continue to service the surrounding communities and counties. The majority of our efforts depend on JAG funding, which provides the task force with manpower that would not be available without JAG funds. The JAG grant funds 13 salary positions with overtime for MoWIN. They are as follows; five (5) positions from Clay County, four positions (4) from Platte County, two positions (2) from Jackson County, and two positions (2) from the Kansas City, Missouri Police Department (BOPC). JAG funds are also used to pay some of the overtime expenses of the listed Kansas City, Missouri detectives whose salaries are funded by KCPD but assigned to MoWIN.

The MoWIN Task Force investigates a wide range of narcotics offences ranging from street level narcotics distribution cases to large scale narcotics investigations. The MoWIN Task Force is focusing efforts on the interdiction of narcotics before they reach the hands of distributors within the Kansas City Metropolitan area and other points of distribution. MoWIN also addresses issues of drug abuse, possession, and sales within its service area. The MoWIN Task Force addresses the issues by focusing enforcement efforts on area transportation systems used by drug traffickers to smuggle illegal narcotics and narcotics proceeds to and from source cities. The MoWIN Task Force is successful at intercepting narcotics and narcotics proceeds by concentrating interdiction efforts at various transportation facilities, as well as several parcel companies in the metro area. Members of the MoWIN Task Force also conduct hotel/motel interdiction, highway interdiction, and interdiction at the Kansas City International Airport.

MoWIN provides a variety of services to its geographical area. MoWIN interdicts large quantities of illegal narcotics, currency, contraband, and apprehends fugitives. They conduct hotel/motel and commercial motor vehicle interdiction. MoWIN dismantles, disposes, and prosecutes meth labs and marijuana grows. MoWIN assists agencies with processing and filling drug possession cases for prosecution, investigating drug complaints, and undercover activities & enforcement. MoWIN participates in Veterans' and Drug Courts, drug take-backs, and hosts a variety of drug and drug trend education programs. MoWIN provides drug sweeps with their K-9's for schools who request those types of services. MoWIN works with pharmacies to gather information about suspicious purchases which may be used as precursors for manufacturing or distributing illegal narcotics.

If the JAG funds were not available, MoWIN would not have the necessary manpower to stay in existence and continue to serve the west-central portion of Missouri. The funding received from JAG reduces heavy financial burdens on the counties and city agencies which MoWIN serves. MoWIN depends on JAG funding to continue to provide a high quality service to the citizens of its service area through education and prevention efforts, narcotics investigation, apprehension, and prosecution. JAG funding helps supplement the necessary funds to continue to conduct narcotics investigations and share information from multiple agencies with the merger of them. MoWIN takes its responsibilities seriously as it relates to the Opiate crisis that is plaguing the United States. MoWIN works hard at interdicting illegal narcotics to include heroin and fentanyl. When possible, MoWIN conducts controlled deliveries of the interdicted narcotics and makes every attempt to bring those believed to be involved with them to justice. MoWIN has also taken a proactive position on educating many local law enforcement officers and their partners in safety measures and precautions when encountering fentanyl or any unpackaged powder. MoWIN participates in Drug Court to assist those struggling with drug addiction. Many of these efforts are manpower intensive and occur after normal business hours. JAG funding is crucial to keep the necessary effort to combat narcotics use, addiction and trafficking.

Without JAG, it would be nearly impossible for parent agencies of MoWIN to allocate manpower and resources it currently has to combating crime and providing its current level of resources including involvement to education, treatment and prevention as described in this segment of the application.

Due to the size of MoWIN and its duties, the Missouri Department of Public Safety has approved the task force to not have all members trained in Clandestine Meth Lab Certification. The decision was made based on the fact several members are currently certified and it would have not made sense financially to spend the training funds on the entire task force.

The Kansas City Missouri Police Department has a Metro Meth Section assigned to MoWIN that is comprised of one (1) KCPD Supervisor, three (3) KCPD detectives, one (1) Clay County Deputy, and two (2) KCMO PD Civilian lab technicians assigned to MoWIN full-time and one (1) part-time Civilian from the Kansas City Regional Crime Lab. These individuals are responsible for clandestine labs and cover any meth lab call outs in Jackson, Clay, Platte, and Caldwell Counties. The individuals are available to all law enforcement in our region on a twenty-four hour basis. The Metro Meth Unit works with MoWIN on a daily basis and investigates meth lab reported crimes in conjunction with interdiction duties. Metro Meth would handle any meth lab related responsibilities that would arise, allowing the MoWIN detectives to continue narcotics related duties.

Prescription Drug Take-Backs.

MoWIN's primary responsibility is the enforcement of laws governing narcotics. MoWIN also takes ownership in other community efforts such as education, prevention, and rehabilitation issues, which may be an underlying or root issue of many offenders involved with narcotics. MoWIN takes an active role in coordinating and staffing eleven (11) local "drop off" sites during the DEA's National Drug Take-Back program twice a year. The program allows the community to have a safe option to dispose of unwanted or unused prescription drugs. Participation in the program also allows MoWIN members the opportunity to have face-to-face personal contacts with the community resulting in information sharing regarding issues they may want to convey to law enforcement. The eleven drop off spots are spread out through Jackson, Clay, and Platte Counties.

This is done in an effort to prevent prescription drugs from getting in the hands of those who have no valid or legal right to possess them. In 2017, MoWIN collected 3849 pounds of prescription drug from the citizens who wished to dispose of them.

Continuing Education efforts conducted by MoWIN.

MoWIN takes great pride in opportunities to provide education to its law enforcement partners and the community it serves. During the 2017 year, MoWIN hosted several training events covering current issues facing its community. Examples of those educational events are below.

Members conduct investigations classes to police recruits at the KCMO Regional Police Academy (Clay County) several times during the year. The course covers general narcotics investigation methods. Classes also cover many different aspects of investigation from drug recognition and identification, concealment methods, investigative options, undercover operations and career paths available to those wishing to further their experiences in narcotics investigations. This training is an already coordinated program that MoWIN participates in.

Members also conduct a class to the police recruits, active officers, and continuing education about Survival Mentality at the Regional Police Academy (Clay County). The class is geared towards educating officers about critical incidents, dangers, and stressors that go hand-in-hand with policing, methods of dealing with those issues and the resources available to officers. The class is instructed by narcotics detectives assigned to MoWIN who have had decades of experience in narcotics investigations, high risk, dynamic search warrant entries and arrests. It is an already coordinated program that MoWIN participates in.

Members of MoWIN coordinate and conduct K-9 demonstrations and drug 101 presentations at area high schools, civic groups, community groups, and mental health providers (Jackson and Clay Counties). The purpose of this is to educate the community on current narcotic trends and issues. The course provides instruction on identifying different narcotics and gives resources to those who currently are or know someone struggling with addiction. The presentation also has examples and photos on-hand for the attendees to view and ask questions.

MoWIN also participates in an already coordinated career day with the United States Postal Service called Center for Advanced Personal Studies (Johnson County, Kansas). The program is designed to support and educate high school students who are interested in pursuing a career in law enforcement. Members provide information to the students about law enforcement as well as conducting K-9 demonstrations. This is hosted a few times annually.

MoWIN has an active role in the already coordinated Peer Court (Jackson County) which is attended by area high school students interested in a career in law enforcement. Participation in the program allows members to visit with the students about being an officer and the different experiences they have had in law enforcement. Members discuss how to become an officer and different opportunities and positions available within law enforcement.

Members of MoWIN coordinate and conduct numerous training classes covering interdiction techniques and methods with other law enforcement agencies and drug task forces (Jackson County). The training covers parcel and transportation interdiction methods.

In light of the recent spike in contacts with fentanyl and exposure issues, MoWIN developed and coordinated the implementation of safety procedures and standards and hosted training for the Kansas City,

Missouri Police Department at the Regional Police Academy (Clay County). They also have brought the training to other law enforcement and probation/parole agencies at their request.

Members of MoWIN provided educational "101" on the dangers and consequences of drug use at a church camp in Rushville, Mo. MoWIN conducted two presentations covering drug education and prevention at West Platte R III and Platte County High School (Platte County).

Veterans' Court

Members of the MoWIN Task Force currently attend weekly meetings with Clay County Drug and Veteran Court programs. MoWIN assists with the coordination of the program. Members help screen possible applicants and address any issues that may arise with current participants. MoWIN has a mentor assigned to the VA court. They attend a weekly meeting to go over issues and assist new applicants with getting proper care needed from the VA Hospital. This program is only available to veterans who are accused of or charged with non-violent offenses relating to drug, alcohol and simple assault. The program was designed to assist veterans with effects or issues they may be suffering from, which could be affecting their personal lives, leading to the committed offenses. MoWIN participates in weekly meetings and is available 24/7 to lend support or be an outlet for the veterans who may find themselves in crisis while in the program. The mentor from MoWIN has had many of the participants call him to discuss issues of harming themselves or relapsing on drugs or alcohol. He has been a direct liaison to help prevent them from taking negative steps which could have huge impacts on their ability to complete the program successfully.

The veterans' program is under the jurisdiction of the 7th Circuit Court, Division 1 of Clay County, Missouri. The court sessions are held at 2:00 pm on Fridays. MoWIN members assigned to the program assist veterans in every ethical way possible to ensure a successful outcome from the program. The program is five phases, with some being required to complete live-in drug and alcohol treatment programs which may last 3 to 90 days. Upon successful completion of the program, the veteran's charges may be expunged. MoWIN will continue to participate and assist with the coordination and monitoring of the Veterans' Court program during the 2018-2019 JAG Grant year.

Drug Court

A member of MoWIN from the Clay County Sheriff's Office attends the previously coordinated weekly staffing sessions which are normally held on Friday mornings before the actual drug court docket is called. Drug Court is held in Division I of the 7th Judicial Circuit Court - Clay County. During staffing sessions, progress of the offenders is discussed with the entire team. Those in attendance in addition to the MoWIN members are additional drug court (Law Enforcement) trackers, Division I Judge, Missouri State Probation and Parole, Treatment Court Coordinator, substance abuse counselors as well as staff from local mental health institutions. The program is offered to non-violent offenders and is a five phase program lasting 18-24 months. The program is designed to reduce recidivism rates, provide early intervention, reduce the number of probation revocation from the Department of Corrections and provide a safer community for Clay County residents.

MoWIN Task Force serves the west-central portion of Missouri. The counties which make up MoWIN's service area are Jackson, Clay, Platte, and Caldwell. These four counties and the cities within them will be the primary focus area for the task forces efforts. Total population in the four counties service area is roughly 1,012,876 citizens and covers 1882 square miles.

All members of the Interdiction Side of MoWIN have been deputized by the DEA making it possible to expand our investigations well beyond our current jurisdictional boundaries set by municipalities, or county and state lines.

This Missouri Western Interdiction and Narcotics (MoWIN) Task Force, like the previous Task Forces that now make up MoWIN TF, was created using JAG Funding. The personnel positions were created with the sole purpose of establishing this task force. All of the personnel positions on this grant application have never been included or paid for by any other funding source and are currently funded through the federal JAG grant which ends 06/30/18. Additionally, all agencies are providing additional local resources to further supplement federal funding. While each agency does contribute additional resources to the task force, there is not sufficient funding in each agency's local operating budget to fully fund the project.

If federal forfeiture funds are received based solely on grant funded task force officer activity, the MoWIN Task Force program income will be tracked and kept in a separate account by each agency for task force usage. The only expenses paid for by these funds would be those allowable by the Guide to Equitable Sharing for State and Local Law Enforcement Agencies and will be previously unbudgeted expenses.

Projected total task force expenses exceed JAG funding. Expenses in excess of available JAG funds will be covered by other sources. These other sources include local funds, outside agency contributions, federal forfeiture sharing funds, and/or other grant funds. Federal JAG money will be used to supplement, not replace, monies that are available to further the outcome of the project.

FACILITY USE AGREEMENT

THIS FACILITY USE AGREEMENT (hereinafter "Agreement") is made and entered into this _____ day of _____, 2018, by and between THE CITY OF LEE'S SUMMIT, MISSOURI, BY AND THROUGH THE LEE'S SUMMIT PARKS AND RECREATION BOARD (hereinafter "LSPR") and JACKSON COUNTY PARKS AND RECREATION (hereinafter "Jackson County.") WITNESSETH:

WHEREAS, pursuant to the Charter of the City of Lee's Summit, Missouri, the Parks and Recreation Board is empowered with the control of the supervision, improvement, care and custody of parks and recreation activities in the City of Lee's Summit, Missouri; and,

WHEREAS, under the direction of the Parks and Recreation Board, LSPR regularly partners with Jackson County, a political subdivision in the State of Missouri, for the provision of various activities for residents and patrons of the City of Lee's Summit and surrounding communities; and,

WHEREAS, one such series of programs provides activities for physically and mentally challenged citizens of the community, said programs being sponsored by Jackson County and held at LSPR facilities, which represents a cost effective and efficient use of public funds and resources; and,

WHEREAS, the Visionary Task Force set forth goals to address the need for programs and activities for the physically and mentally challenged citizens of our community; and,

WHEREAS, LSPR and Jackson County agree that joint cooperation and partnership of programs and use of facilities and grounds, represents a cost effective and efficient use of public funds and lands; and,

WHEREAS, LSPR and Jackson County desire to enter into a formal agreement outlining the terms and conditions associated with a partnership for such programming for the 2019 year.

NOW, THEREFORE, In consideration of the mutual benefits and provisions set forth herein, LSPR and Jackson County do hereby agree upon the following terms and conditions:

Section One: Facilities, Services and Activities

1. **Facility.** LSPR agrees to provide accommodations to Jackson County for the activities described herein at Harris Park Community Center or, if the facility is unavailable, at the sole discretion of LSPR, another facility capable of accommodating the activity to be held. The facility accommodations to be provided by LSPR shall include preparation and set up of any courts, rooms, or other needs of the activity. LSPR further reserves the right to reschedule an activity authorized under this Agreement for usage of the facility by LSPR or for other emergency or urgent needs, at the discretion of LSPR. In the event of a reschedule for this purpose, LSPR agrees, to the extent possible, to provide a minimum of twenty four (24) hours' notice to Jackson County.
2. **Activities.** For the term of this Agreement, LSPR agrees to provide accommodations for Basketball, Volleyball and Dance special population programming offered by Jackson County.
3. **Schedule.** Prior to October 1 of each year, Jackson County shall provide a proposed schedule of activities for the upcoming calendar year to LSPR for consideration. LSPR will review the schedule and advise Jackson County of any conflicts or concerns with the accommodations requested. LSPR and Jackson County shall cooperate to prepare a mutually agreeable final calendar of activities for the upcoming calendar year no later than December 1 of each year for the term of this Agreement.
4. **Fees.** LSPR agrees to waive any rental fees against Jackson County which would typically be assessed for the uses described herein for the term of this Agreement.
5. **Event Participation Estimates.** At least ten (10) calendar days prior to the commencement of an activity authorized under this Agreement, Jackson County shall provide to LSPR an estimate of the number of participants and spectators for the event, including an estimate of the number of vehicles for which parking is needed.
6. **Request for Additional Equipment or Accommodations; Provision of Equipment.** Any request for special equipment for a particular activity must be made by Jackson County a minimum of thirty (30) calendar days



in advance of the activity's scheduled start date. LSPR will exercise its' best efforts to accommodate any request for additional equipment. In the event that Jackson County wishes to provide its' own equipment for an activity or event, it shall notify LSPR at least fourteen (14) calendar days in advance in order to allow LSPR to ensure the equipment is acceptable for use at the facility.

Section Two: Responsibilities of Jackson County

1. **Parking at LSPR Facilities.** Jackson County will strictly regulate the parking of vehicles. Parking attendants shall be provided by Jackson County and coordinated with the LSPR Inclusion Coordinator or his or her designee for the duration of the activities authorized under this Agreement. No parking is permitted on outer roads and service drives. Violators will be towed at owner's expense. Jackson County shall not charge a parking fee without the prior written authorization of LSPR.
2. **Condition of LSPR Facilities.** Jackson County agrees that it will not alter or in any way cause to be altered LSPR property, unless prior written consent has been granted by LSPR to Jackson County.
3. **Adherence to Rules and Regulations.** Jackson County agrees to abide by all facility and LSPR rules and regulations are followed and agrees to enforce or assist LSPR in the enforcement of said rules and regulations with regard to the activities authorized in this Agreement.
4. **Damage to LSPR Facilities or Equipment.** Jackson County shall be responsible for reimbursing LSPR for the cost of replacement or repair of any LSPR property or equipment damaged through the negligence of or the acts or actions of participants or spectators of the events and programs authorized under this Agreement.
5. **Event Control.** Jackson County shall be responsible for the events authorized under this Agreement, and shall take all steps necessary to prevent the violation of facility regulations, City ordinances, park rules or regulations, or any act or action that might be detrimental to LSPR, its Board, facilities, patrons, volunteers, employees, guests. Such regulations and ordinances shall include, but are not limited to: use of tobacco in the parks, prohibition of food and beverages on gymnasium floors or restrooms, prohibition of alcohol on LSPR premises without applicable permits, and the adherence to all applicable fire codes, including parking and occupancy requirements. Jackson County shall ensure that a representative of Jackson County who is responsible for event control and has authority to enforce rules and regulations related to the activity is on site at all times during the provision of activities authorized under this Agreement.
6. **Unsafe Conditions.** Decisions regarding the safety of holding or continuing to hold an activity or event as authorized under this Agreement shall be the sole responsibility of Jackson County. Jackson County shall immediately notify LSPR of any unsafe conditions observed with regard to LSPR's facilities or equipment.
7. **Participant Safety.** Jackson County will be solely responsible for providing participant safety, supervision, and first aid supplies it deems necessary in connection with the activities authorized under this Agreement. LSPR does not provide on-site emergency medical care or any vehicle for emergency medical transportation.
8. **Clean Up.** Jackson County shall be responsible for returning facilities and grounds to their original condition upon completion of the activity or event. This shall include, but is not necessarily limited to bagging trash, removing all food or containers, setting out trash, and dry and wet mopping as needed.

Section Three: General Conditions

1. **Term.** The Term of this Agreement shall be from January 1, 2019 to December 31, 2019, and shall be eligible for up to two (2) additional one (1) year renewal terms. In the event that Jackson County desires to renew this Agreement, it shall submit to LSPR its' intent to renew no less than thirty (30) days prior to the natural expiration of this Agreement.
2. **Termination.** Either party has the right to terminate this Agreement prior to the natural expiration of the same by providing written notice to the other party not less than fourteen (14) days prior to the intended date of termination.
3. **Insurance.** Each party to this Agreement shall be solely responsible for any and all actions, suits, damages, liability, or other proceedings brought against it as a result of the alleged negligence, misconduct, error, or omission of any of its officers, agents, employees, volunteers, guests, invitees, or participants. Neither party is obligated to indemnify the other party or to hold harmless the other party from costs or expenses incurred as a result of such claims. The foregoing provisions shall not be deemed a relinquishment or waiver of any kind of applicable limitations of liability provided or available to the parties under applicable



state governmental immunities law and each party shall continue to enjoy all rights, claims, and defenses available to it under law, to specifically include Mo. Rev. Stat. § 537.600, et seq. Jackson County shall provide the Board a certificate of insurance indicating coverage naming the City of Lee's Summit, Missouri, as additional insured. This coverage must provide a general aggregate liability of \$2,000,000 to cover all operations included herein. Alternatively, JCPR may elect to self-insure this risk. If JCPR so elects, it shall provide to the Board upon request evidence satisfactory to the Board of said self-insurance.

- 4. **Governing Law.** This Agreement shall be deemed to have been made within the County of Jackson, State of Missouri, and shall be interpreted, construed, and enforced in accordance with the laws of the State of Missouri and before the Courts of Missouri in the County of Jackson.
- 5. **Severability.** In the event any term or other provision of this Agreement is determined by a court of competent jurisdiction to be invalid, illegal, or incapable of being enforced, all other terms, provisions, and conditions of this Agreement shall nevertheless remain in full force and effect.
- 6. **Waiver.** Any waiver by LSPR or Jackson County of any of the covenants, conditions, or agreements herein contained shall not be construed as a waiver of any subsequent breach or violation of this Agreement.
- 7. **Assignment.** This Agreement may not be assigned by either LSPR or Jackson County without the prior, written consent of the non-assigning party.
- 8. **Entire Agreement.** This Agreement contains the entire agreement with respect to the matters herein described, and there are no terms, conditions, promises, understandings, or statements, express or implied, concerning the same. No subsequent alteration, amendment, change or addition to this Agreement shall be binding upon LSPR or Jackson County unless reduced to writing and signed by both LSPR and Jackson County.

Every day, more than 1,000 men and women come to work for Jackson County, many of whom will spend years or even decades in service to the County. Each and every one of them deserves to know that when they need it, the pension they worked so hard to earn will be there for them.

Recently, a “super-majority” of our County Legislature voted to make changes to the county’s pension system. These changes include, most notably, provisions allowing certain county retirees to return to full-time work while simultaneously drawing a pension from the county. To be clear, if I were still a member of the Legislature I would have joined the minority and voted against this change. My vote in opposition would have been based, in large part, upon the unanimous recommendation of the County’s Pension Board. It is concerning when the body that has been created by the County Legislature to manage and protect our pension system votes unanimously in opposition to a proposal, yet six members of the Legislature nevertheless vote to support the change. In addition, at this time we still do not have an estimate of the cost to the pension system to implement such a change. However, similar provisions have been found to cost public pensions millions of dollars annually.¹

As County Executive, I do not have a vote on the matter and my charter authority to request reconsideration would most certainly have been overridden by the same six legislators that voted for this proposal. While I have chosen not to sign the Ordinance, I have chosen not to go through the disapproval process and instead am offering the support and cooperation of my administration to the legislators that will be seated in less than a month to work together on addressing this issue.

In conclusion, today I have issued Executive Order #18-22. This executive order modifies the county’s existing personnel rule by prohibiting certain county retirees from returning to full-time employment within a year of retirement. Without this executive order, certain county employees would be able to retire, start drawing their monthly pension payments and return to work immediately while still receiving their pension payments. While this change will limit potential abuse of the new pension provisions, legislative action will be required to fully address this issue.
