#### 5 COMMUNICATIONS AND REPORTS OF THE COUNTY EXECUTIVE

Katheryn Shields, County Executive, said Jackson County has been leading an effort to bring to Kansas City the largest gathering of local leaders in the nation. She was pleased to announce that Jackson County will host the 2008 National Association of Counties Annual Conference. Since it is a presidential election year, we expect to attract nationally prominent speakers to the conference. NACo attracts approximately 5,000 delegates and is projected to generate 5 million for our economy. Jackson County vied with 5 other major cities which included Chicago, Minneapolis, Pittsburgh, Portland and Orlando. Competition was tough and it came down to Nashville and Kansas City. The conference will go to Nashville in 2009.

She said she was pleased for the entire metropolitan area because it required a combined effort crossing many city and county borders, including the state line. Jackson County will serve as the official host, but it is truly a team effort and she said she appreciates the contributions made and yet to be made by other cities, counties, businesses and organizations. Our partners include: Kansas City, Missouri, Cass County, Missouri, Clay County, Missouri, Greater Kansas City Convention and Visitors Bureau, Johnson County, Kansas, Missouri Association of Counties and Platte County, Missouri. Much work remains to be done by each of the partners, but this is truly a success to celebrate.

She thanked NACo President, Karen Miller, a fellow Missourian and Boone County Commissioner, for all her assistance in this process. She also thanked the Legislature for their support.

Katheryn Shields gave results for the on-line tax payment in 2003 and they are record breaking. In 2002, Jackson County had about 8,700 transactions. In 2003, we had over 13,600 transactions. The largest increase was in total dollar amount. In 2002, Jackson County had over \$5.8 million in on-line payments and in 2003, we more than doubled that amount to over \$13 million. In 2002, the largest single on-line payment was about \$100,000. In 2003, the largest single on-line payment was for over \$1.3 million.

She said the "on-line, not in line" strategies are paying off for the citizen in shorter lines and waits. During the traditional end-of-year rush, lines were shorter than ever because of on-line payment, the lock box arrangement with UMB Bank and a renewed commitment to customer service. She thanked the Legislators for their consistent support of these efforts.

Scott Burnett thanked Katheryn for her efforts in getting Jackson County to host the NACo conference.

Ronald E. Finley, County Legislator, said he would like to continue to be involved in the planning of the 2008 NACo Conference.

Katheryn Shields suggested forming a committee that includes some of her staff and some legislators. They would continue to work with the Convention and Visitors Bureau and work on raising \$800,000.00 to make good on our campaign commitment. She said Jackson County has identified about half of the contributions.

Scott Burnett suggested putting together a committee to discuss criteria for waiving fees and penalties on property taxes. Katheryn Shields agreed.
