## Lisa Lassman Briscoe, AIA Resume

Lisa Lassman Briscoe joined PBA in 2003. Ms. Lassman Briscoe has over 20 years professional historic preservation planning and architecture experience and is a registered architect in Missouri. She practiced architecture in the private sector for several years before entering the non-profit sector working as a historic preservation architect for the Historic Kansas City Foundation, whose emphasis was rehabilitation of historic structures and preservation easements. She entered the public sector in 1989 joining the City of Kansas City, Missouri, City Planning and Development Department, where she served two management roles, including division manager of Historic Preservation Management and Planning, Preservation & Urban Design. Most notably, she served as the Administrator of the Kansas City, Missouri Landmarks Commission (CLG) for nine years, and the Missouri Advisor for the National Trust for Historic Preservation for three years, and past Board Member of Preservation Action. In addition, she served as Executive Director of the Landmarks Historic Trust Corporation, a non-profit corporation dedicated to the preservation of historic properties through the acceptance of preservation easements and the administration of special projects. Ms. Briscoe has been responsible for the design and management of innovative programs and plans from concept to launch including the Missouri-Kansas Heritage Corridor Study, Historic Resources Survey Plan, Archaeological Resources Master Plan, and Town of Kansas Archaeological Park Master Plan, and many others. She was an active project manager with the award-winning FOCUS Kansas City planning process, from the initial Perspective Groups through project management for the FOCUS Preservation Plan through Council adoption. In addition, she was responsible for undertaking Federal Section 106 review and compliance requirements for other city departments and agencies and provided guidance to private developers for compliance with 106 Review. She is a current member of the Union Station Preservation Advisory Committee, charged by Federal Programmatic Agreement to serve as steward for the historic structure and its grounds, and member of the Board of Directors, Historic Kansas City Foundation.

He became interested in early American history from bicycling most of the historic trails in the United States, including the Oregon Trail, Santa Fe Trail, Natchez Trace, Blue Ridge Parkway, C & O Canal and parts of Route 66. He completed a solo and unsupported ride in 2004 of the Lewis and Clark Trail from St. Charles, Missouri to Astoria, Oregon. In 2006, he bicycled 1243 miles to his 50<sup>th</sup> class reunion in Durham, North Carolina.

## Kathy Smith Resume

My family traveled the country due to my father's employment. He always chose older homes for us to live in. It was because of this aspect of my childhood that I came to appreciate older homes. I always felt that they have a comfortable feeling and provided a background for my active childhood imagination.

My first experience in old house exploring was as a child living in Kansas City, Kansas around the 53<sup>rd</sup> and Gibbs Road area. A house that our neighbor told us was a Civil War house was calling my name. It was of the simple style of homes of that era. It was white clapboard. The windows were tall and the rooms were small. Looking at historical photos of Lee's Summit I have noticed the similarities in Civil War homes in this area to that of the Gibbs Road home. My siblings and I had a ball exploring every nook and cranny of the home. Looking back I think that house was ready to fall down.

The first historic house that I helped save was the Rice Tremonti Home located on 67th and Blue Ridge in Raytown, Missouri. The home, which is a good example of Greek revival architecture, was built by Archibald Rice and was a stopping point on the Santa Fe Trail. Over night a development sign went up in the yard of the home and I new I had to get to work. I called several people in the Raytown area and one phone call led me to Sylvia Mooney who knew all of the right things to do. Eventually the house was saved and is now owned by the City of Raytown.

My next foray in to house preservation was working with a group from Lee's Summit who were trying to save the Todd George home. By this time I had been a resident of Lee's Summit for several years. I had always admired the Todd George home and did not want developers to remove it. We ended up saving the house.

Eventually I applied to be on the Historic Preservation Commission and was accepted. I have been on the Commission for several years now. The chair of the Preservation Commission and I have worked hard to give the community of Lee's Summit an insight into its history. We have organized 2 walking tours of the Downtown and 1 of the Lee's Summit Historical Cemetery. All three of the events were successful.

I am also in the Lee's Summit Historical Society. I have given many talks to the children of Lee's Summit regarding the history of our town. I have given numerous walking tours of the downtown. I spend a lot of my time gathering historic photos and artifacts for the Lee's Summit Historical Society Museum. I have written many articles for the Lee's Summit Journal and continue to have a passion for the history of Lee's Summit and surrounding areas.

This summer with the help of the City of Lee's Summit Public Works Department, I was able to remark the historic Jefferson Highway. This was a highway that was known as the Palm to Pine Highway and went from New Orleans to Winnipeg.

My latest venture is to establish a new site for the Lee's Summit Historical Society Museum.
