# 5 COMMUNICATIONS AND REPORTS OF THE COUNTY EXECUTIVE

Katheryn Shields, County Executive, announced that Irving Achtenberg died last Monday. Mr. Achtenberg was a lawyer who was dedicated to fairness and equality for everyone. He fought hard for civil rights, trying to open up the Kansas City Bar Association to women and African-Americans. He also fought and won three cases before the United States Supreme Court; two expanding the principle that every vote should be counted equally and one establishing that cities violating the constitutional rights of its citizens cannot claim immunity. Mr. Achtenberg was politically active as well. He helped found the Jackson County Young Democrats and the Democratic Council of Jackson County. He was also involved in the local NAACP, ACLU and the American Veterans Committee. He was the first non-African American to receive the NAACP's Harold Holiday award for his work on the behalf of the advancement of civil rights. She extended her condolences to all who knew Irving Achtenberg and asked for a moment of silence to observe the loss of one of Jackson County's finest citizens.

Mark Trosen, Development Administrator/Public Works Department, reported on the progress of the food inspection program in Jackson County. In the fall of 2001, the Administration presented a comprehensive plan. With the approval of the Legislature, the 1999 Missouri Food Code was adopted, salary adjustments for food inspectors were made competitive with other jurisdictions and funding was provided for an additional animal control officer, so the department could assign the nuisance control responsibilities to the animal control division and dedicate three full time employees to food inspections. Also, laptop computers and software were purchased and are being used by the inspectors. In 2001, the department permitted 659 food establishments. All establishments were inspected at least once and 84% of the establishments were inspected twice in 2001. The establishments that received one inspection are considered low priority. He thanked the County Executive and Legislature for their support in the food establishment program and asked if they had any questions.

Victor E. Callahan, Chairman, commended Mark Trosen on the hard work he has put into the program and said he appreciated his leadership.

Ronald E. Finley, County Legislator, asked if the city of Lee's Summit is taking any steps to do their own inspections.

Mark Trosen said not to his knowledge.

Katheryn Shields said the only correspondence they have had with the cities in Jackson County was in 1999 when we informed them that the inspection fees for restaurants would be increased so that we could hire more inspectors.

Victor E. Callahan asked if 2 inspections per year was the goal.

Mark Trosen said food establishments are prioritized. High priority establishments are inspected 2-3 times per year, low priority are inspected two times per year. High priority food establishments include busier locations as well as buffets.

# 14 NEW BUSINESS

Victor E. Callahan, Chairman, asked Jane McQueeny, County Counselor, about a County Commission that had a ruling against it.

Jane McQueeny responded that it was not true.

Victor E. Callahan asked when she would address the Legislature regarding this matter.

She said she sent a memo to the Legislature.

Mr. Callahan said he received the memo right before the issue went to court. He asked if the County Counselor planned on having an executive session so that she could discuss the judge's ruling with the members of the Legislature.

Ronald E. Finley said in her memo it states that three members were fined because of violations of the open meeting laws. It is his understanding that two are members of the commission and one is the Executive Director of the Office of Human Relations and Citizen Complaints. He asked if the individuals have personal liability or was it the County's liability.

Ms. McQueeny said Katheryn Kedigh from her office defended the lawsuit. The judge did not find that there is a County liability as the County is not a party to this lawsuit. It is a charter obligation to defend our Boards and Commissions.

Victor E. Callahan said citizens serve on Boards and Commissions and are not compensated. He thinks that a policy needs to be discussed as to whether the members will be held individually liable or if the County should pay their fines. He said the County Counselor's office should inform the Legislature since there may be budgetary considerations and appropriations that may need to be made with regard to this case.

Jane McQueeny said so far the amount of the fines is \$500; \$100 for each member and \$300 for the Director. She said Judge Clark will issue his final decision by February 8, 2002 and no hearing is contemplated. She said the fines would be self-executing, which means they would be paid out of the County's self insurance fund.

Ronald E. Finley suggested that the County Counselor schedule an executive session after February 8 so that she can give a full report to the Legislature on this lawsuit.
