**TITLE:** A Resolution awarding a contract to purchase TruNarc, from Thermo Fisher Scientific of Tewksbury, Massachusetts, under the terms and conditions of GSA Contract No. GS-07F-6099R, an existing and competitively bid government contract. TruNarc is a handheld narcotics analyzer that provides rapid and accurate identification of controlled substances. Requesting a transfer in the amount of \$38,496.00, from various accounts within the 2025 Jackson County Sheriff's Office, Detention Center General Fund, to cover the cost of this purchase.

**SUMMARY:** Pursuant to Section 1030.4, of the Jackson County Code, the Jackson County Sheriff's Office, Detention Center requests approval to purchase TruNarc, a handheld narcotics analyzer that provides rapid and accurate identification of controlled substances from Thermo Fisher Scientific of Tewksbury, Massachusetts, under the terms and conditions of GSA Contract No. GS-07F-6099R, an existing and competitively bid government contract. TruNarc will improve staff safety by minimizing the risk of directly contacting unknown substances, reducing exposure to staff. The device will provide instant identification results, eliminating the need for lengthy lab testing and will allow

expedited decision making in emergent situations. Implementing this technology will significantly improve security, efficiency, and safety within our facility. This purchase will be made by transferring funds from various accounts within the General Fund of the 2025, Jackson County Sheriff's Office, Detention Center budget. This purchase will not exceed \$38,496.00. We will need the following transfer totaling \$38,496.00 from the following accounts: \$15,000.00 (56085 Temp Agency), \$15,000.00 (5172 Inmate Transportation) and \$8,496.00 (58172 Printers and Scanners) transferred to 57192 (Safety Equipment).
