In Consideration of the mutual promises and undertakings hereunder, and for the good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Parties hereby agree;

- 1) The following location is added to Exhibit A of the original Agreement, as provided for in paragraph 2; to wit:

"SUBJECT. ... It is expressly agreed by and between the Parties that Exhibit A may be modified and amended from time to time..."

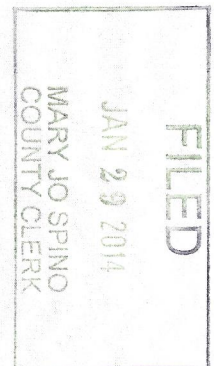

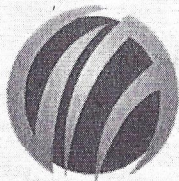
- 2) Exhibit B of the original Agreement is modified as follows, effective September 25, 2013:

- 3) Paragraph 14. "Termination" of the original agreement is modified as follows:

"UMC may immediately terminate service to any location on Exhibit A of this Agreement in the event fewer than the minimum allowable withdrawals have occurred per month in any two consecutive calendar months during any term of the Agreement. The Jackson County Courthouse has a minimum allowable withdrawal threshold of two hundred (200) withdrawals per month. The Independence Courthouse and the Truman Courthouse each have a minimum allowable withdrawal threshold of one hundred (100) withdrawals per month."






