LS Bid Proposal August 12, 2024

Scope of Work & Clarifications

Lytle Construction, Inc. is pleased to provide this Lump Sum bid proposal for the proposed Old Health Department Building Demolition Project based on on-site discussions and the scope of work outlined below.

The LS, proposal amount for the work described is as follows:

Base Bid		\$ 105,345.00	45 Calendar Day Duration
Payment & Performance Bond	ADD	\$ 2,050.00	0 Calendar Days
Hazardous Material Survey/Report	ADD	\$ 1,375.00	0 Calendar Days

Base proposal includes the following clarifications:

- 1 On-Site, working/part-time supervision is included for a 6 week onsite construction duration.
 - Assumes full access to any/all existing Mechanical/Electrical Rooms, Plumbing/Fire Line pits/penetrations/shut-offs, or any other existing Equip, Support, Elect., Chase and Roof areas required
- 2 Part-time Project Mgmt/office personnel, considered actual job costs, in lieu of overhead.
- 3 Excludes Payment & Performance Bonding as this Project value does NOT exceed \$150,000
 - ADD \$ 2,050.00 to include Contractor P/P Bond
 - Standard Builder's Risk Policy in place.
- 4 Includes Temporary Facilities per below:
 - Provide and install approx. 800Lft of temporary 6ft site security chain link fencing panels, Tposts, driven posts, sandbags, gate(s), per attached diagram, for Project duration. Contactor NOT responsible for damage/theft.
 - Includes removal and haul upon completion
 - Includes temporary restroom facilities for Contractor use, for Project duration
- 5 Includes Selective Interior Demolition, removal, and proper disposal of existing components in conflict with Structural Demolition, in order to accommodate this scope of work
 - Assumes all Owner items, Equipment, Medical/Patient Records, and BioSafety cabinets materials to be verified and cleared prior to start of Demolition, by Others
 - Assumes all Owner/County owned/salvageable items including copiers, furnishing, equipment, and personal belongings be removed prior to start of work
 - Daily cleanup and removal of misc. debris to dumpsters, provided by Contractor
 - Select Interior Demolition limited to single visible layer only.
 - Additional layers or concealed components are considered unforeseen
- 6 Removal of any hazardous materials or materials suspected of containing Asbestos and/or Lead Paint, to be removed/mitigated/abated by Others.
 - Assumes Owner can provide appropriate Hazardous Material Survey/Reporting documentation/verification
 - ADD \$ 1,375.00 to include Contractor provided Hazardous Material Survey/Report required prior to Start of Work
- 7 Includes Structure Demolition generally described/associated with removal/demolition of (1) existing 2 story/basement Building approx. 40ft x 90ft as well as (1) existing "double wide" mobile office trailer, as they currently exist onsite
 - Building: Provide all labor, materials, and equipment to demolish the building.
 - Obtain all permits required by the governing authority for the demolition.
 - Existing Evergy & Spire utilities disconnected by Others (see below Mechanical/Electrical scopes).
 - Water & sewer line disconnect by Others (see below Mechanical scope)
 - Demo 2 story building and office trailer.
 - · Haul all debris to a legal landfill.
 - · Level lot, seed, and straw.
 - Site: Concrete, Asphalt, and Saw Cut. Existing concrete/asphalt parking & drive lanes to remain as possible
 - Excludes Concrete or asphalt removal greater than 8 inches thick.
 - Excludes Dust control/mitigation, Freon recovery, Telephone pedestals, Tree removal, and Shoring of any kind
 - $\bullet \, \underline{\textbf{Excludes}} \, \text{removal of Evergy Transformers. All transformers to be removed Owner} \\$
 - <u>Excludes</u> removal/disposal of Tires. Any tires are found on the property, will require an additional charge
 - Demo Contractor to retain Salvage Rights to any/all equipment/materials/components remaining at Start of Work

Mechanical Scope of Work Includes the following:

- 1 Includes GPRS to verify utility locations.
- 2 Includes cut and cap fire main just outside of vault.
- 3 Includes cut and cap storm and sanitary sewer @ main.
 - Existing storm and sanitary piping sizes are unknow at time of bid
 - Assumes above piping is 8" or smaller and NOT deeper than 6ft
 - Includes cut and cap domestic water line @ main.
- 5 Includes cut and cap gas line @ main.

6 Includes providing safety shoring as needed to perform above Mechanical scope

Electrical Scope of Work Includes the following:

- 1 Includes labor and material to remove the main electrical feeder pipe and wire above ground from the existing utility pole to the main building
 Conduit to be cut off/capped at the ground
- 2 Includes removal of the electrical service from the main building to the trailer setting beside the main building.
- 3 Includes coordination and scheduling of Independence Power and light to get the existing service disconnected from the pole mounted transformers
- 4 Excludes any and all work not outlined above

The following items are specifically excluded from the estimate:

- 1 Asbestos abatement or hazardous material abatement of any nature
- 2 Premium time labor (expect tie-in or shutdowns) or accelerated schedule, except where specifically noted.
- 3 Actual and/or Liquidated Damages of any kind. No terms have been outlined at time of bid.
- 4 State, County, Municipal Building Permits, MO sales/use/remodel tax, and unique insurance requirements, and Payment Performance Bond where project value is less than \$150,000.00.
 - Associated Tax Exemption Certificates required prior to start of work.
- 5 Any work not specifically listed above
