Quality Custom Construction Genesis Environmental Solutions McConnell and Associates Corporation During the evaluation process, Gensis and McConnell were eliminated for not meeting the response deadline. An Executive Summary of the Invitation to Bid, including the Contractor's Quotation Sheet and the using County Departments Recommendation Memos are attached.
