Parks + Rec requires fuel dispensing equipment for several locations within the park system. The Purchasing Department issued ITB No. 24-78, Fuel Dispensing Equipment to meet those needs. The bid produced one (1) submission from Petroleum Equipment, Inc. of Kansas City, MO whom the Purchasing Department deemed as meeting all County requirements for the bid.

After reviewing the bid proposal, pursuant to Section 1054.6 of the Jackson County Code, Parks + Rec recommends Petroleum Equipment, Inc. as the lowest and best bid received for all scopes of work.

The Parks + Rec Department has conducted business with PEI for several years. Their customer service is highly responsive, and they have ample stock to quickly meet our needs.
