

COOPERATIVE AGREEMENT

AN AGREEMENT by and between Jackson County, Missouri, hereinafter referred to as "the County" and the **Mid-America Regional Council**, 600 Broadway, Suite 200, Kansas City, MO 64105, a regional planning commission operating pursuant to Section 251.150 et seq., RSMo, hereinafter referred to as "MARC."

WHEREAS, the County deems it to be in the best interest of its citizenry to provide support for an initiative to bring the 2016 Republican National Convention to the Kansas City area; and,

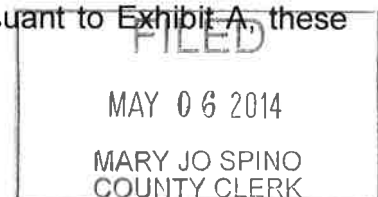
WHEREAS, MARC is the designated agency coordinating the bi-state effort to host a visit of the 2016 Republican National Convention Site Selection Committee; and,

WHEREAS, this Agreement is authorized by Resolution 18482, dated April 14, 2014; therefore,

The County and MARC agree, in consideration of the following mutual promises and valuable consideration, as follows:

1. **Services to be provided.** MARC shall create an account to manage contributed funds from four government entities participating in the initiative in a total amount of \$260,000.00, to promote the Kansas City metropolitan area as host of the 2016 Republican National Convention, as is more fully set out in the document attached hereto as Exhibit A.

2. **Terms of Payment.** County shall pay to MARC the total sum of \$65,000.00 for such services upon the execution of this Agreement. Pursuant to Exhibit A, these



for those services actually performed as verified by the County's audit as provided in paragraph 4 above.

6. **Equal Opportunity.** In carrying out this Agreement, MARC shall insure that none of the benefits or services of the program are denied to any eligible recipient on the basis of race, color, religion, sex, age, handicap or national origin. MARC shall take affirmative action to insure that applicants are employed, and that employees are treated during employment without regard to their race, color, religion, sex, age, handicap or national origin in terms and conditions of employment or termination, rates of pay or other forms of compensation and selection for training including apprenticeship. MARC shall in all solicitation or advertisements for employees placed by or on behalf of MARC, state that all qualified applicants will receive consideration for employment without regard to race, color, religion, sex, age, handicap or national origin.


7. **Employment of Unauthorized Aliens Prohibited.** Pursuant to §285.530.1, RSMo, MARC assures that it does not knowingly employ, hire for employment, or continue to employ an unauthorized alien to perform work within the State of Missouri and/or Jackson County, and shall affirm, by sworn affidavit and provision of documentation, its enrollment and participation in a federal work authorization program with respect to the employees working in connection with the contracted services. Further, MARC shall sign an affidavit, attached hereto and incorporated herein as Exhibit B, affirming that it does not knowingly employ any person who is an unauthorized alien in connection with the contracted services.

8. **Incorporation.** This Agreement incorporates the entire understanding and

agreement of the parties.



Enclosed please find an invoice for expense related to the pending visit of the 2016 Republican National Convention Site Selection Committee.

As you know, this contribution was discussed in recent meetings of the chief elected and administrative officials of Johnson County, Kansas, Unified Government of Wyandotte County/Kansas City, KS, Jackson County, Missouri and Kansas City, Missouri. All four entities are requested to contribute \$65,000 each to a pool of funds to be administered by Mid-America Regional Council.

MARC will create a separate account to manage the contributed funds and will pay expenses incurred and documented by the Greater Kansas City Convention and Visitors Bureau to host the site selection committee visit, anticipated in May 2014. Expenses eligible to be paid with these include delegate hotels, meals, transportation, and events, as well venue rental, communications materials, professional services and other functions. The funds will not be expended on alcohol or personal entertainment. MARC will seek guidance from the contributing jurisdictions on the use of any residual funds following the site selection visit.

WORK AUTHORIZATION AFFIDAVIT

As a condition for any service provided to the County, a business entity shall, by sworn affidavit and provision of documentation, affirm its enrollment and participation in a federal work authorization program with respect to the employees working in connection with the contracted services.

Business entity, as defined in section 285.525, RSMo pertaining to section 285.530, RSMo, is any person or group of persons performing or engaging in any activity, enterprise, profession, or occupation for gain, benefit, advantage, or livelihood. The term "business entity" shall include but not be limited to self-employed individuals, partnerships, corporations, contractors, and subcontractors. The term "business entity" shall include any business entity that possesses a business permit, license, or tax certificate issued by the state, any business entity that is exempt by law from obtaining such a business permit, and any business entity that is operating unlawfully without such a business permit.

Every such business entity shall complete the following affidavit affirming that it does not knowingly employ any person who is an unauthorized alien in connection with the contracted services. The completed affidavit must be returned as a part of the contract documentation.

This affidavit affirms that **Mid-America Regional Council**, (Organization name) is enrolled in, and is currently participating in, E-verify or any other equivalent electronic verification of work authorization operated by the United States Department of Homeland Security under the Immigration Reform and Control Act of 1986 (IRCA); and, **Mid-America Regional Council**, does not knowingly employ any person who is an unauthorized alien in conjunction with the contracted services.

In Affirmation thereof, the facts stated above are true and correct. (The undersigned understands that false statements made in this filing are subject to the penalties provided under section 575.040, RSMo.)
