A RESOLUTION authorizing the County Executive to execute Cooperative Agreements with certain agencies that provide services and assistance to victims of domestic violence, at an aggregate cost to the County not to exceed \$148,295.00.

WHEREAS, pursuant to section 8700., <u>Jackson County Code</u> (1984), the Board of Domestic Violence Shelters was established to administer the distribution of certain fees collected pursuant to state statutes and the Code; and,

WHEREAS, Hope House, Rose Brooks, New House, and Synergy domestic violence shelters are not-for-profit organizations providing assistance to victims of domestic violence; and,

WHEREAS, the Board met December 6, 2023, and recommended an allocation of \$148,295.00 of the projected 2024 budget revenues to be awarded as follows:

WHEREAS, the Board recommends that the County Executive be authorized to execute cooperative agreements with the specified agencies, in the respective amounts indicated, at an aggregate cost to the County not to exceed \$148,295.00; and,

WHEREAS, it is in the best interests of the public health, safety, and welfare of the citizens of Jackson County to provide assistance to the victims of domestic violence through the funding of these shelters; now therefore,

BE IT RESOLVED by the County Legislature of Jackson County, Missouri, that the County Executive is authorized to execute Cooperative Agreements, in a form to be approved by the County Counselor, with Hope House, Rose Brooks, New House, and Synergy domestic violence shelters in the amounts indicated, at a total cost to the County not to exceed \$148,295.00; and,

BE IT FURTHER RESOLVED that the Director of Finance and Purchasing is authorized to make all payments, including final payment on the Agreements.

Effective Date: This Resolution shall be effective immediately upon its passage by a majority of the Legislature.
