WHEREAS, pursuant to section 1030.1 of the <u>Jackson County Code</u>, the Director of Finance and Purchasing recommends the award of a twelve-month term and supply contract for the furnishing of reinforced concrete pipe for use by the Public Works Department to Cretex Concrete Products Midwest of Shawnee, KS, as a sole source purchase; now therefore,

BE IT RESOLVED by the County Legislature of Jackson County, Missouri, that award be made as recommended by the Director of Finance and Purchasing and that the Director

be, and is hereby, authorized to execute for the County any documents necessary to the accomplishment of the award; and,

Concrete Pipe - Cretex Concrete - Sole Source 2012

I am asking for your approval and Ms. Kneauvean's approval for the Sole Source purchase of the commodity Reinforced Concrete Pipe for 2012.

I request Cretex Concrete be considered Sole Source vendor for reinforced concrete pipe. This company is the only company in the area that has the ability to fabricate concrete box structures the size and configurations we order. These massive structures must be formed and then moved to the job site, unloaded by crane, and set in place. No other company, to our knowledge and according to the Purchasing Department's research, has the ability to provide this commodity.

In the event we were able to locate a company outside the Mid-state area that could possibly form these structures, the cost of delivery would increase the price considerably and the ability to off-load and set in place with a crane would not be available.

According to our knowledge, Cretex Concrete, formerly Kansas City Concrete Pipe, has been the only bidder since 1998; no information available prior to 1998. It is my opinion that Cretex Concrete should be considered a sole source vendor for reinforced concrete pipe.
