**MISSOURI HIGHWAYS AND TRANSPORTATION COMMISSION  
SAFE ROUTES TO SCHOOL PROGRAM SUPPLEMENTAL AGREEMENT**

THIS SUPPLEMENTAL AGREEMENT is entered into by the Missouri Highways and Transportation Commission (hereinafter, "Commission") and Jackson County Sheriff's Department (hereinafter, "Grantee").

WITNESSETH:

WHEREAS, on October 28, 2010, the Commission and the Grantee previously entered into a Safe Routes to School Program Agreement for Safe Routes to School program activities designated for Indian Creek Elementary School (hereinafter, "Original Agreement"); and

WHEREAS, the Commission and the Grantee now desire to revise the Original Agreement.

NOW, THEREFORE, in consideration of the mutual covenants, promises and representations contained herein, the parties agree as follows:

(1) **REVISION:** Paragraph 14C of the Original Agreement is hereby removed and replaced with the following:

The completion time of this project/activity has been extent for the 2013/2014 school year. In the event the Grantee does not complete the project/activity within the new timeline set forth, all monies previously programmed or spent for this project/activity shall be surrendered by the Grantee at this time to the Commission. **Any costs incurred by the Grantee prior to authorization from FHWA and notification to proceed from the Commission are not reimbursable costs.**

(2) **ORIGINAL AGREEMENT:** Except as otherwise modified, amended, or supplemented by this Supplemental Agreement, the Original Agreement between the parties shall remain in full force and effect and shall extend and apply to this Supplemental Agreement as if fully written in this Supplemental Agreement.
