BE IT RESOLVED by the County Legislature of Jackson County, Missouri, that the County Counselor be and hereby is authorized to settle the claims of Louella Wilkins in the lawsuit styled <u>Louella Wilkins vs. Jackson County, MO</u>, Case 0816-CV19031, by the total payment of \$25,000.00, in full, final and complete release of all of the claims

against the County and all of its employees, officers, agents, and servants, as to any damages incurred; and,

BE IT FURTHER RESOLVED that the County Counselor be and hereby is authorized to execute any and all documents necessary to effect this settlement; and,

BE IT FURTHER RESOLVED that the Director of Finance and Purchasing be and hereby is authorized to issue a check or checks in an amount totaling \$25,000.00 in full and complete settlement of this claim, payable to Louella Wilkins and/or her attorney, Christopher Wirken, pursuant to the specific direction of the County Counselor.
