

FIRST ADDENDUM
SUPPORT AND SOFTWARE MAINTENANCE
SERVICES AGREEMENT

THIS FIRST ADDENDUM made this 24th day of February, 2016, by and between **JACKSON COUNTY, MISSOURI**, (hereinafter called "County") and **FIRST CALL ALCOHOL/DRUG PREVENTION & RECOVERY, INC.**, 9091 State Line Road, Kansas City, MO 64114, hereinafter called "First Call."

WITNESSETH:

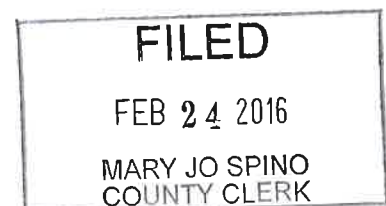
WHEREAS, First Call and County entered into a Support and Software Services Agreement dated November 30, 2012, whereunder First Call agreed to provide software maintenance and support for the substance abuse treatment data tool, COMBAT~Connections, as a sole source purchase, at an annual cost to the County of \$28,800.00; and,

WHEREAS, the parties now desire to expand the scope of that Agreement at an additional cost to the County;

NOW, THEREFORE, in consideration of the foregoing and the terms and provisions herein contained, County and First Call respectively agree with each other as follows:

1. Except as expressly provided herein, all provisions of the Support and Software Services Agreement dated November 30, 2012, between First Call and County shall remain in full force and effect.

2. The Scope of Services shall be amended to include enhancements to the COMBAT~Connections software to improve COMBAT'S ability to draw evaluative



conclusions about the value of treatment services. Specifically, First Call shall add six specified questions to the on-line Connections intake form

3. First Call shall be paid for these services at the rates specified in Exhibit A, at an additional cost not to exceed \$4,750.00, to be paid upon the completion of this additional work.

4. This First Addendum shall be effective January 1, 2016, and shall extend until June 30, 2016.


5. This First Addendum, together with the Agreement dated November 30, 2012, incorporates the entire understanding and agreement of the parties.
