WHEREAS, by Resolution No. 21597, dated April 15, 2024, the Legislature did authorize auction services for the sale of County owned property and equipment to Purple Wave of Manhattan, KS; and,

WHEREAS, the Director of Finance and Purchasing recommends that the County-owned vehicles listed on the attached declaration and transfer form be declared surplus and unusable and disposed of via auction by Purple Wave pursuant to section 1131.1 of the Jackson County Code, 1984; and,

WHEREAS, the Sheriff's Office has requested, and the Director of Finance and Purchasing recommends that any unusable vehicles listed on the attached forms be declared surplus and disposed of pursuant to section 1141. of the Jackson County Code; now therefore,
