BE IT FURTHER RESOLVED that the Director of Finance and Purchasing be and hereby is authorized to issue a check or checks in an amount totaling \$270,000.00, in full and complete settlement of this claim, payable to Derek Matthew Jackson and/or his attorneys, Foland, Wickens, Eisfelder, Roper & Hofer, P.C, pursuant to the specific direction of the County Counselor.
