WHEREAS, by Ordinance 4513, dated March 11, 2013, the Legislature did authorize the appropriation of funds in the amount of \$273,057.00 for this renovation; and,

WHEREAS, by Resolution 18118, dated March 11, 2013, the Legislature did authorize Change Order No. 1 to the contract with Universal Construction of Lenexa, KS, for the renovation of the Tourism Department offices; and,

WHEREAS, the attached Agreement with the City of Independence is a suitable

mechanism by which to implement the mutual understanding of the parties with regard to this additional renovation of the Tourism Department offices; and,

WHEREAS, execution of this Agreement is in the best interest of the health, safety, and welfare of the citizens of Jackson County; now therefore,

BE IT RESOLVED by the County Legislature of Jackson County, Missouri, that the County Executive be and hereby is authorized to execute the attached Agreement with the City of Independence, Missouri.
