TRENDS



LOCAL TRENDS

- The weekly overall COVID-19 case rate in Eastern Jackson County has **increased** every week since the week of 10/24/21. The current case rate is **1227.17 per 100,000 population**, which is 10 times higher than the CDC designation for "High Transmission."
- The COVID-19 case rate for unvaccinated individuals for the week of 12/26/21 was 2.45 times higher than the case rate for fully vaccinated individuals.
- The week of 1/2/22 saw the **most** cases in children under the age of 5 compared to any other week in the pandemic. This is the fifth record-setting week in a row.
- The week of 1/2/22 had not only the **highest number of tests** conducted in one week (12,142), but it also had the **highest percent positive** compared to any other time in the pandemic (36.0%).
- Daily Average New Hospitalizations across the region remain high at **245 hospitalizations** per day a change of 9.36% over last week.



COVID-19 Cases by Event Date and Case Status, Eastern Jackson County, 2020-2022

















Percentage of COVID-19 Case-Patients 5-18 Years of Age and Total COVID-19 Cases by Week, Eastern Jackson County, 2020-2022



VACCINATIONS

- The 25-34 age group has the lowest vaccination completion percentage of all fully eligible age groups (49.37%), with the exception of the newly authorized 5-11 year olds. The 25-34 age group continuously maintains among the highest case rates as well, currently holding the highest COVID-19 case rate for the month of December.
- The number of people who are receiving a booster COVID-19 dose is inadequate to stall the surge of COVID-19 infections.
- As a population, vaccination rates are inadequate to prevent another surge of COVID-19 cases.






COVID-19 CASE RATE BY VACCINATION STATUS

Fully Vaccinated: Has completed a COVID-19 vaccination series and, if due, received a booster dose











STRAIN ON THE HEALTH CARE SYSTEM

- Daily Average of New Hospitalizations for the MARC region increased substantially, from 198 daily new hospitalizations on 1/5 to 238 on 1/12, marking a 20.3% increase in the last week.
- This is the highest number of daily new hospitalizations experienced in the pandemic.
- HCA is also postponing procedures "because we are not only facing the highest number of COVID patients we have ever seen, but that is in the face of some of the most extreme staffing shortages we've ever seen as well," said Dr. Kim Megow.
- "December saw a five-fold increase in the number of patients who have died while waiting for a transfer from an emergency room, Dr. Richard Watson said. Some of them waited as much as 20 hours in the emergency room, and then died before they could be transferred, he said."








EJC COVID-19 HOSPITALIZATIONS BY VACCINATION STATUS
