

**ADDENDUM AND EXTENSION  
TO CONSULTING AGREEMENT**

**THIS ADDENDUM AND EXTENSION TO CONSULTING AGREEMENT** is made and entered into on this 12<sup>th</sup> day of February, 2026, by and between **JACKSON COUNTY, MISSOURI**, hereinafter called the "County" and **FRED DREILING, LLC**, 1025 W. 64<sup>th</sup> Terr., Kansas City, MO 64113, hereinafter called "Consultant."

**WITNESSETH:**

WHEREAS, via Resolution 20841, dated December 13, 2021, the County did engage Consultant to perform consulting services for the County in the areas of intergovernmental relations, in accordance with the terms, conditions, and covenants as set forth in a Consulting Agreement dated December 22, 2021 ("the Prior Agreement"); and,

WHEREAS, Consultant and County have agreed to extend the Prior Agreement as authorized by Resolution 22137;

NOW, THEREFORE, in consideration of the foregoing and the terms and provisions herein contained, County and Consultant respectively promise, covenant, and agree with each other as follows:

1. Except as specifically provided herein, the Prior Agreement of December 22, 2021, shall remain in full force and effect pursuant to its terms.
2. The term of this Addendum and Extension to Agreement shall be effective as of January 1, 2026, and extend until December 31, 2026. Pursuant to paragraph 6 of


the Prior Agreement, the parties have the option of renewing the Prior Agreement through December 31, 2026.


