of Finance and Purchasing recommends award to Petroleum Equipment Inc., of Kansas City, MO, for the reason that it has submitted the lowest and best bid; and,


WHEREAS, this award is made on an as needed basis and does not obligate the County to pay any specific amount; now therefore,






