5 COMMUNICATIONS AND REPORTS OF THE COUNTY EXECUTIVE

Katheryn Shields, County Executive, announced that Jackson County and the Jackson County Historical Society will be hosting the opening night of the World Premier of Breath of an American Spirit: Sacagawea at the Coterie Theatre in Crown Center on opening night September 27, 2001. This event is an unofficial beginning for Jackson County's 175th Anniversary Celebration, the actual anniversary date is December 15th.

The play is the story of Sacagawea, the Native American woman who helped Lewis and Clark on their historical expedition. The evening will include refreshments catered from D'Bronx and a viewing of the play. Tickets are \$10 and can be purchased by calling the Jackson County Historical Society at 461-1897.

Katheryn Shields reported that County volunteers sold over 450 papers on Red Friday to raise money for several charities sponsored by the Kansas City Chiefs. She thanked Fred Arbanas' aide, Karen Conrad, for helping organize this event.

Ronald E. Finley, County Legislator, asked about the memorandum he received regarding the shortfall in sales tax projections.

Katheryn Shields responded that due to the sluggish economy, Jackson County has fallen short of projected sales tax revenues for the first two quarters of 2001. If this trend continues it will create an estimated \$2.5 million shortage in the 2002 budget projections. Additional items in the 2002 budget such as election costs, health insurance increase and the employee merit pool will be impacted by this shortfall. In the Kansas City Star last week it was reported that the City of Kansas City is looking at a \$10.5 million deficit for 2002. Cities such as Blue Springs, Olathe and Overland Park are all experiencing projection shortfalls due to a faltering economy and sales and income tax revenues.

In light of this, the Administration has implemented a limited hiring freeze for all non-essential job openings from September 1, 2001 through the end of the year. This does not include the Collection's or Sheriff's Department. All County Departments have been notified and are making every attempt to find ways to be more frugal with their expenses. Departments are also trying to increase the fund balance by decreasing expenditures from 2001. Katheryn Shields is confident that this sales tax shortfall can be overcome so that Jackson County can still provide the citizens with the best possible services.

Ronald E. Finley, County Legislator, asked if the health insurance plans could go out for bid.

Katheryn Shields said that she would get information and report on this matter at the legislative meeting next week.

Ronald E. Finley asked Ms. Shields to come forward with budget issues so that the Legislature and Administration can work together.

Victor E. Callahan, Chairman, asked if the Records Department is still on schedule for the 7 day return of titles as he has been receiving calls from constituents.

Katheryn Shields replied yes, and said they are trying to process titles on the same day.
