Dan Tarwater moved the passage of Ordinance #4134 as perfected, rescinding Ordinance 4132, dated August 10, 2009, which submitted to the qualified voters of Jackson County a question authorizing the continuation of a county-wide anti-drug sales tax, and submitting to the qualified voters of Jackson County at a special election to be held on Tuesday, November 3, 2009, a revised question authorizing Jackson County to continue its county-wide anti-drug sales tax (COMBAT) at the rate of one-quarter of one percent for a period of seven years for the purpose of the arrest, prosecution, incarceration, treatment and prevention of drug related offenses and violent crimes, and the judicial processing of adult and juvenile violators of such offenses. Seconded by Henry C. Rizzo.
