**TITLE:** Awarding a contract for the purchase of a Mobile Communications/Command Center vehicle for use by the Sheriff's Office to Farber Specialty Vehicles, Inc. of Reynoldsburg, Ohio, in the amount of \$720,450 under the terms and conditions of Henrico County, Virginia, Contract No. 2578A, an existing competitively bid government contract, in cooperation with GovMVMt, a national cooperative purchasing program.

**SUMMARY:** The Sheriff's Office is the 911 Public Safety Answering Point and Dispatch Center provider for the Sheriff's Office and ten (10) other law enforcement or law enforcement-adjacent agencies (Buckner Police, Grain Valley Police, Greenwood Police, Jackson County Circuit Courts, Jackson County Park Rangers, Lake Lotawana Police, Lake Tapawingo Police, Lone Jack Police, Missouri Department of Conservation Agents and Oak Grove Police). The Sheriff's Office provides these communication services from the Communications Center at Sheriff's Office Headquarters. The Sheriff's Office is requesting to purchase a Mobile Communications/Command Center vehicle to provide both a short-term backup communications center, and/or an on-scene communications and

command center for on-site response to emergency or large-scale public safety incidents in Eastern Jackson County served by the Sheriff's Office and/or outside agencies including those for whom the Sheriff's Office provides communications services. Pursuant to Section 1030.4 of the Jackson County Code, the Sheriff's Office and the Purchasing Department recommend the purchase of the Mobile Communications/Command Center vehicle for \$720,450 from Farber Specialty Vehicles, Inc. of Reynoldsburg, Ohio, under the terms and conditions of Henrico County, Virginia, Contract No. 2578A, an existing competitively bid government contract, in cooperation with GovMVMТ, a national cooperative purchasing program.
