ConvergeOne provides products and services, including pre-sales support, installation, engineering, helpdesk/telephone/electronic support, maintenance, and professional services. ConvergeOne also will provide new and unused equipment and accessories under this procurement contract. IT also has a requirement of Professional Services on an "as needed" basis. The

Pursuant to Section 1030.4 of the Jackson County Code, the Director of Finance and Purchasing recommends the awarding of Term and Supply Contracts for the furnishing of Personal Computers, Miscellaneous Computer Hardware, Software, Maintenance and Professional Services for use by Various County Departments to ConvergeOne under the terms and conditions of Cooperating School Districts of Greater Kansas City Contract No. CO62518 an existing competitively bid other-government contract. This award is made on as "As Needed" basis and does not obligate Jackson County to pay any specific amount. The availability of funds for specific purchases is subject to annual appropriation.
