6 PERFECTION OF PROPOSED ORDINANCES AND REPORTS OF COMMITTEE

Appropriating \$7,000,000.00 from the undesignated fund balance of the 2021 CARES Act Fund and authorizing the County Executive to execute a commercial real estate sales contract for the purchase of a certain property for use as the new Health Department headquarters, and authorizing such additional contracts as are necessary to renovate, improve, and furnish the aforementioned property, subject to the provisions of chapter 10 of the County Code, at an aggregate cost to the County not to exceed \$7,000,000.00

Jay Haden, Chief Deputy County Counselor, said he has a copy of the sales agreement available for review by the Legislature but the document is confidential until approved.

5515 Appropriating \$250,000.00 from the undesignated fund balance of the 2021 CARES Act Fund to allow for reimbursement to certain eligible outside agencies in Jackson County of eligible costs related to testing and vaccination during the ongoing Coronavirus/COVID-19 pandemic and authorizing the County Administration to solicit proposals from eligible outside agencies, at an aggregate cost to the County not to exceed \$250,000.00.

Ronald E. Finley, County Legislator, said he has previously shared his concerns regarding the need to establish a fleet plan to coordinate the County's acquisition, maintenance, and utilization of fleet vehicles.

20690 Authorizing an increase to term and supply contract no. 70-17 with Pure Water Oasis of Independence, MO, for the furnishing of bottled water service for use by various County departments. (Assigned to the Finance and Audit Committee.)

13 UNFINISHED BUSINESS

Crystal Williams, County Legislator, asked about the move to cease providing audio service for the Legislative meeting and if it is possible to resume live streaming. Dan Tarwater III, County Legislator, said they will work toward making sure that live streaming is implemented. Scott Burnett, County Legislator, said he wants to be able to listen to the Legislative meeting through Bluetooth technology. Troy Schulte, County Administrator, said he will follow up on these issues with the Communication Department.

14 NEW BUSINESS

Jalen Anderson said in reference to the air conditioning repairs, the Finance offices are hot and he asked about the County's policies regarding an associate who has health conditions that are affected by the heat. Troy Schulte said those associates will need to use their sick leave if they are unable to work in the building without air conditioning. Mr. Schulte said the Administration is trying to keep the building open for business during this time. He said they are still on track to restart the system on June 25 and hope to avoid impacting County operations. He said some departments are able to work from home in afternoons and other departments have made the decision to stay open. Mr. Anderson said it is not the associates' fault the air conditioning does not work. He believes associates should not have to use sick leave in these instances and requests that the Administration reconsider this policy.

Jeanie Lauer, County Legislator, asked about the work from home policy. Mr. Schulte said if the heat index in a department exceeds 80 degrees, and if work can be done remotely, the department director has the discretion to allow for remote work.

Jalen Anderson said in Blue Summit the fence is down around the school. Homeless people are again living around that building. He asked about the status of this contract on the old Blue Summit school. He asked if the project has fallen through and if it may now be necessary for the County to tear the building down. He said we must take care of this area since it is directly reliant on the County. Frank White, Jr., County Executive, said he will follow up with Land Trust and will invite Michael Hunter, Executive Director of Land Trust, to give an update on the project.

Ronald E. Finley assumed the duties of Chairman.

Ronald E. Finley, County Legislator, asked to meet with Brian Gaddie, Director of Public Works, after the meeting. He asked about policies regarding workplaces requiring proof of vaccine before returning to work. Troy Schulte said there are onsite vaccination events planned for County work sites. The Administration continues to encourage associates to get vaccinated. They are looking at a policy to lift the mask mandate for associates who are vaccinated. The Administration is also looking at various incentives for associates to encourage vaccinations.
