**A RESOLUTION** awarding a nineteen-month term and supply contract, with three twelve-month options to extend, for the furnishing of ice machine rental services for use by various County Departments to Easy Ice, of Lenexa, KS, under the terms and conditions set forth in 16<sup>th</sup> Judicial Circuit of Missouri Contract No. 10002261, an existing competitively bid government contract.

WHEREAS, various County departments are in need of ice machine rental services to cover preventive maintenance, winterization, and any “as needed” cleaning, service or equipment repairs; and,

WHEREAS, pursuant to section 1030.4 of the Jackson County Code, the Director of Finance and the Purchasing recommends the award of a nineteen-month term and supply contract, with three twelve-month options to extend, for the furnishing of ice machine rental services for use by various County Departments to Easy Ice, of Lenexa, KS, under the terms and conditions set forth in 16<sup>th</sup> Judicial Circuit of Missouri Contract No. 10002261, an existing competitively bid government contract; and,

WHEREAS, award under the existing government contract, is recommended to take advantage of the discounts offered to larger entities; and,

WHEREAS, this award is made on an as needed basis and does not obligate Jackson County to pay any specific amount, with the availability of funds for specific purchases subject to annual appropriation, annual estimated spend for this contract is \$35,500.00; now therefore,

BE IT RESOLVED by the County Legislature of Jackson County, Missouri, that the award be made as recommended by the Director of Finance and Purchasing and that the Director be, and hereby is, authorized to execute for the County any documents necessary to the accomplishment of the award; and,

BE IT FURTHER RESOLVED that the Director of Finance and Purchasing is authorized to make all payments, including final payment on the contract and all extensions, to the extent that sufficient appropriations to the using spending agency are contained in the then current Jackson County budget.

Effective Date: This resolution shall be effective immediately upon its passage by a majority of the Legislature.
